

Commercial Dealer Recreational Vehicle Registration for Snowmobiles, All-Terrain Vehicles, Utility-Terrain Vehicles or Off-Highway Motorcycles

Notice: Pursuant to chs. 23 or 350, Wis. Stats., this application may be used for commercial dealer snowmobile, all-terrain vehicle (ATV), utility-terrain vehicle (UTV) or off-highway motorcycle (OHM) registrations. Incomplete applications will not be considered. Personally identifiable information will be used for administrative purposes and may be provided to requesters to the extent required by Wisconsin's Open Records Law (ss. 19.31-19.39, Wis. Stats.).

Instructions: Every person who is a snowmobile, ATV or UTV manufacturer, dealer, distributor, renter or any combination thereof and engaged in business in this state must register with the Department and obtain the applicable commercial certificate. Every person who is engaged in this state in the sale of OHMs for a profit at retail shall register with the Department and obtain a commercial OHM certificate. Registration fees are not prorated. **No person may operate a snowmobile, ATV, UTV or OHM until the decals are received and displayed as required.**
