## Footnotes:

- 1. Fee doubles to \$1,100 if preliminary screening prior to field inspection indicates the possible presence of endangered resources or sites of historical or archeological significance.
- 2. There is an additional \$2,000 fee added to the \$22,000 for each of the following types of exemption requests: (A \$2,000 will only be charged once for each type of exemption, even if there are multiple exemptions of that type. For example, \$2,000 is added only once for a water supply well setback exemption request, even if exemptions are requested for multiple water supply wells).
  - a. s. NR 504.04(3)(a), Wis. Adm. Code, 1,000 ft to a navigable lake or pond;
  - b. s. NR 504.04(3)(b), Wis. Adm. Code, 300 ft to a navigable stream or river;
  - c. s. NR 504.04(3)(d), Wis. Adm. Code, 1,000 ft to any state or federal highway, any public park or state natural area;
  - d. s. NR 504.04(3)(e), Wis. Adm. Code, 10,000 ft of an airport used by turbo jet or 5,000 ft of an airport used by piston aircraft;
  - e. s. NR 504.04(3)(f), Wis. Adm. Code, 1,200 ft of any public or private water supply well;
  - f. s. NR 504.06(2)(b), Wis. Adm. Code, The separation distance between the seasonal high groundwater table and the bottom of the clay component of a composite liner or a clay liner shall be at least 10 feet except for zone–of–saturation landfills;
  - g. s. NR 504.06(2)(c), Wis. Adm. Code, The separation distance between the top of the bedrock surface and the bottom of the clay component of a composite liner or a clay liner shall be at least 10 feet; and,
  - h. ch. NR 140, Wis. Adm. Code, Groundwater standard exemptions (A single \$2,000 fee is charged).
- 3. A plan modification also applies to submittals requesting to change the NR 140 design management zone (DMZ) or requests for approval of indicator preventative action limits (PALs) or alternative concentration limits (ACLs), under chs. NR 507 and NR 140, Wis. Adm. Code.
- 4. An additional \$550 is charged for each construction inspection performed by the DNR, up to 10 inspections per major phase of construction [s. NR 520.04(5), Wis. Adm. Code].
