WHITE LAKE: SLOW-NO-WAKE

ORDINANCE NO. 96-08

The Town Board of the Town of Hartland, Shawano County, does ordain as follows:

- 1.01 **TITLE.** White Lake: Slow-No-Wake Area
- 1.02 **PURPOSE.** To regulate boating upon the waters of White Lake and prescribing penalties for violation thereof.
- 1.03 **APPLICABILITY AND ENFORCEMENT.** The provisions of this Ordinance shall apply to the waters of White Lake. This chapter shall be enforced by the officers of the Town of Hartland.
- 1.04 **INTENT.** The intent of this Ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.
- 1.05 **STATE BOATING AND SAFETY LAWS ADOPTED.** State boating laws as found in ss. 30.50 to 30.71, Wisconsin Statutes, are adopted.
- 1.06 **DEFINITIONS.**
 - a. "Slow-No-Wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.
- 1.07 **CONTROLLED AREA.** No person shall operate a boat faster than slow-no-wake in the waters of White Lake at any time.
- 1.08 **POSTING REQUIREMENTS.** The Town of Hartland shall place and maintain a copy of this section at all public access points within the jurisdiction of the Town of Hartland.
- 1.09 **PENALTIES.** Wisconsin State boating penalties as found in ss. 30.80, Wisconsin Statutes, are adopted by reference.

- 1.10 SEVERABILITY. The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town of Hartland Town Board would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this Ordinance or the application to any person or circumstances is held invalid, the remainder of the Ordinance and the application of such provisions to other persons or circumstances shall not be affected.
- 1.11 EFFECTIVE DATE. This section will become effective upon passage and the day after publication.

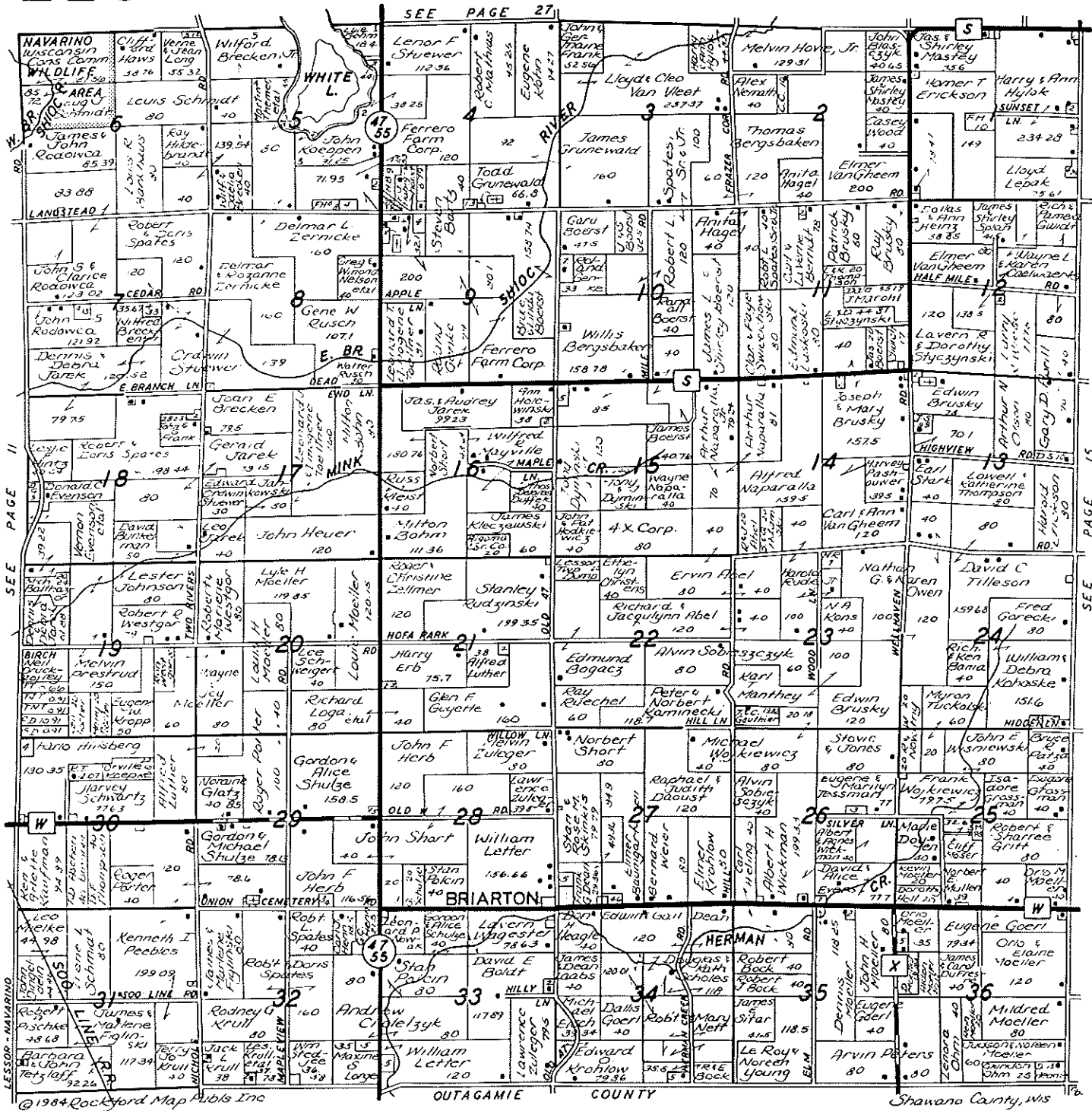

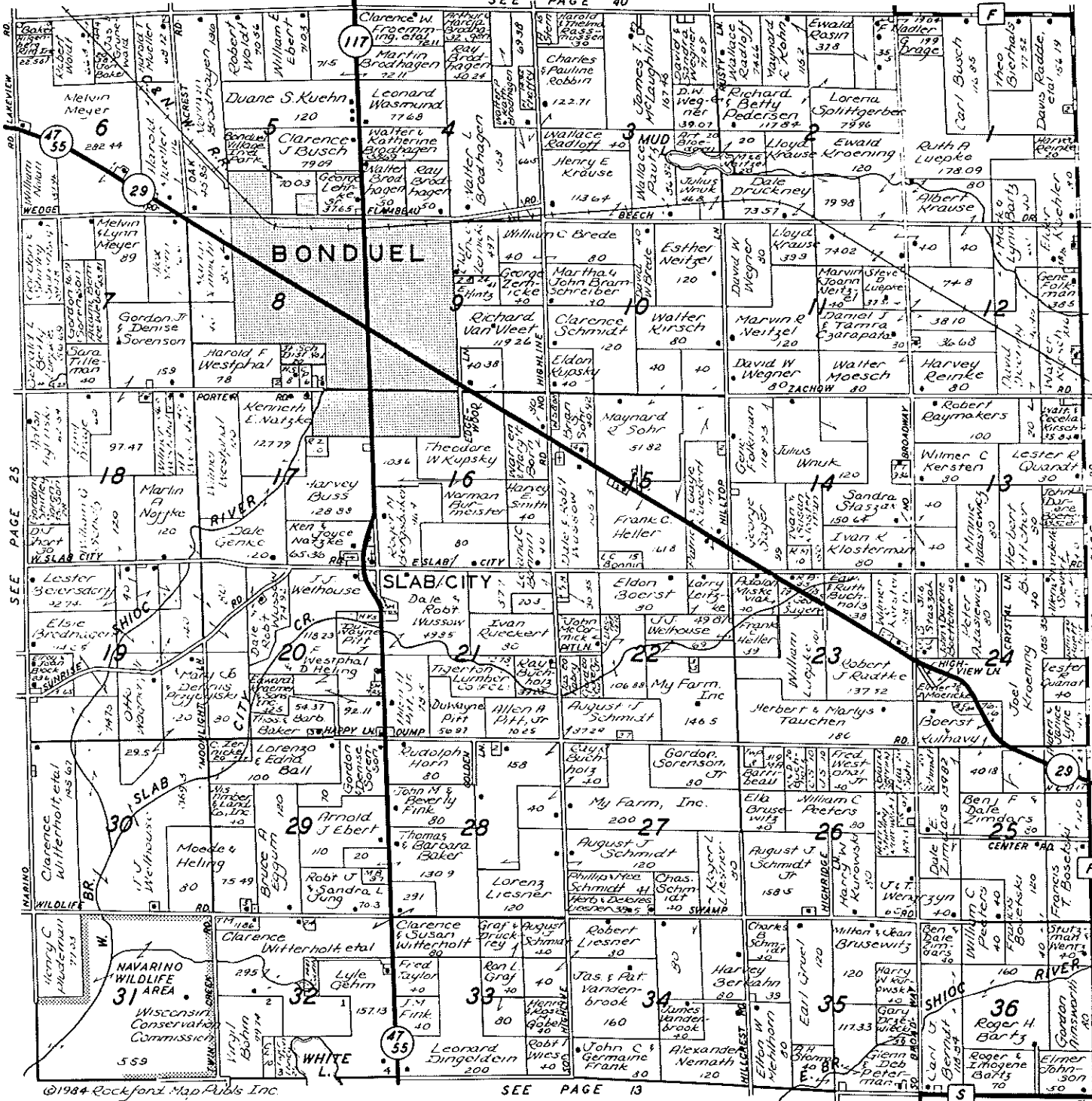
