An ordinance regulating the use of motorboats and water skiing in the Town of Athelstane.

The Town Board of the Town of Athelstane do ordain as follows:

Section 1. <u>Definitions</u>. As used herein, the terms "motorboat" and "operate" shall have the meaning ascribed to them in Section 30.50, Wisconsin Statutes.

Section 2. Mater skiing. No person shall operate a motorboat towing a person on water skis, aquaplane or similar device, nor shall any person engage in water skiing, aquaplaning or similar activity, at any time from sunrise to 10:00 A.M., or at any time between 0:00 P.M., and sunsot on any lake in the Town of Athelstane, Marinette County, Wisconsin.

Section 3. Motorboats. No person shall operate any motorboat having a motor with a braking horse power in excess of 72 on any lake in the Town of Athelstane between the hours of sunrise and 10:00 A.M., or between the hours of 6:00 P.M., and sunset.

Section 4. The above sections shall not apply to any case in which there is an actual emergency requiring a motor in violation of this ordinance. The times referred to above shall be central standard time, or central daylight saving time, which ever is in use in this particular town at the particular time.

Section 5. Penalty. Any violation of this ordinance shall be punishable by a fine not exceeding \$10.00.

Section 6. Severability. In the event that either of sections 2 or 3 hereinabove shall be ruled unconstitutional, by any competent court, such determination shall not affect the validity or effectiveness of the other of said section nor of any other section of this ordinance, and the remainder of said ordinance shall remain of full force and effect.

ORDINACE

The town board of the Town of Athelstane do ordain as follows:

- 1. <u>Intent</u>. The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public needs and the capability of water resources.
- 2. <u>Time Restriction</u>. Motor boat operation, including water skiing, in excess of seven (7) miles per hour shall be permitted only between the hours of 10:00 A.M. and 5:00 P.M. All motor boats are restricted to the speed limit of seven (7) miles per hour between the hours of 5:00 P.M. and 10:00 A.M.
- 3. Tow Lines. Any tow rope shall not exceed seventy-five (75) feet in length.
- 4. Traffic Lien. All motor boats operating at speeds exceeding seven (7) miles per hour shall not be closer than two hundred (200) feet to the shore line.
- 5. <u>Direction</u>. All motor boats shall operate in a counter clockwise direction between the hours of 10:00 A.M. an' 5:00 P.M. and shall remain within established traffic lanes.
- 6. <u>Supervision</u>. No motor boat shall be operated at a speed of greater than seven (7) miles per hour unless there is on board a person at least sixteen (16) years of age and, when skiers are being towed, a competent observer at least seven (7) years of age.
- 7. Negligent Operation. No person shall operate or handle a motor boat in such a manner as to unreasonably annoy, unnecessarily frighten or endanger the occupants of his motor boat or other boats. No person shall operate or handle a motor boat at any time in a careless, negligent or wreckless manner so as to endanger the life or property of another.

- Definition. For the purposes of this ordinance, "motor 8. boat" means any boat propelled by machinery, whether or not such machinery is the principle source of propellsion.
- Any person who violates this ordinance shall Penalty. forfeit not more than \$ 5000 or, in default of payment, shall be imprisoned not more than thirty (30) days. Each day of violation shall conistitute a separate offense.

The foregoing ordinance was adopted by the Town Board of the Town of Athelstane on the 12 day of 1973.
