Dear Mr. Polzin:

Upon review of the attached ordinance, our number 417, we find it to be consistent with ss. 30.50 to 30.71 of the Wisconsin Statutes and Department rules adopted to implement those sections. Please submit a signed copy of the ordinance upon passage. As outlined in s. 30.77(4), Wis. Stats., no ordinance is valid until it is prominently posted at all access points within your jurisdiction and until a signed copy is received by this office.

Please note the posting requirements outlined in NR 5.15, Wisconsin Administrative Code, which require a sign with a minimum of three inch lettering be posted at each public landing outlining all regulations more restrictive than state law.

ORDINANCE	NO

ORDINANCE REGULATING SPEEDY TRANSPORT ON LAKES TO INCLUDE TECHNOLOGICAL ADVANCEMENT OF PERSONAL WATERCRAFT.

- 1. That the provisions of Wisconsin Statutes 30.50 to 30.71, inclusive, are adopted by reference as if fully set forth, with like penalty ranges.
- 2. No person shall engage in water skiing, tubing, surfing or use any other towing device except between the hours of 10 a.m. to 6 p.m. daily. No person shall operate a motor boat or personal watercraft in excess of slow-no-wake between the hours of 6 p.m. to dawn daily.
- 3. This ordinance shall repeal any prior ordinance or portion thereof which is inconsistent with the terms of this ordinance.
- 4. Wisconsin state boating penalties as found in Wisconsin State Statutes 30.80, or its successor, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference, except the town penalty shall be forfeitures with no imprisonment unless ordered by a court for contempt sanction.
- 5. This ordinance is effective, unless otherwise specifically limited, to all lakes within the Cloverleaf Lake chain, Long Lake and Schoenrock Lake.
- 6. This ordinance shall take effect upon passage and publication as provided by law.
