The Town Board of the Town of Plymouth, Wisconsin does hereby ordain as follows:

That the following Chapter of the Municipal Code of the Town of Plymouth known as the Boat Code is hereby amended to read as follows:

That Section C of the Municipal Code of the Town of Plymouth is hereby amended to read as follows:

SECTION C. LOCAL REGULATIONS OF PROHIBITED OPERATION.

(1) That no person may operate a motor boat towing a person on water skis, aquaplane or similar device and that no person may engage in water skiing, aquaplaning or similar activity, at any time from 7:30 P.M. to 10:00 A.M. except to the extent that such activities are prohibited by Sec. 30.69 (1)(a) Wis. Stats.

That Section C (3) of the Municipal Code of the Town of Plymouth, Wisconsin, is hereby repealed.

That Section C (4) of the Municipal Code of the Town of Plymouth is hereby amended to read as follows and is to be renumbered as subsection (3):

(3) In the interest of public health and sanitation, no person shall occupy or cause, or allow to be occupied, any houseboat, raft or other vessel upon the waters of Crystal Lake as a habitation. "Habitation" herein means using such vessel for housing overnight.

That Section C (5) of the Municipal code of the Town of Plymouth, Wisconsin, is hereby amended to read as follows and is hereby renumbered as subsection (4):

(4) A speed limit of slow no wake speed is established upon the waters of Crystal Lake between the hours of 7:30 P.M. and 10:00 A.M. except as prohibited by Wis. Stats. Sec. 30.68.

That Section C (6) is hereby renumbered as subsection (5).

That Section D of the Municipal Code of the Town of Plymouth, Wisconsin, is hereby amended to read as follows:

SECTION D. <u>SUNDAY OPERATION PROHIBITED</u>. (1) There shall be no power boating on <u>Crystal Lake during the hours</u> of 12:01 A.M. to midnight on Sundays, beginning the second Sunday in June, through and

including the second Sunday in September of any year. Power boating is defined as any craft propelled by an electrical, gasoline, diesel or other type of motor.

(2) Commencing the second Sunday in June, 1988 and ending the third Sunday in September of 1988, craft propelled by electric motors and operated at slow no wake speeds shall be allowed on Crystal Lake at all times. In October, 1988, a public hearing shall be held for the purpose of considering whether this subsection should be extended and whether such extension is consistent with Chapter 30, Wis. Stats. as to Public Health, Safety or Welfare. This subsection shall expire unless reinacted subsequent to the public hearing.

That Section E of the Municipal Code of the Town of Plymouth, Wisconsin is hereby amended as follows:

SECTION E. PENALTY. Any person who shall violate any of the provisions of this Chapter shall be subject to the penalties of Wis. Stats. Sec. 30.80 which is hereby adopted by reference.

That Section F. of the Municipal Code of the Town of Plymouth is hereby created to read as follows:

SECTION F. JURISDICTION. It is expressly understood that the jurisdiction over the waters of Crystal Lake is jointly held by the Town of Rhine and the Town of Plymouth.
