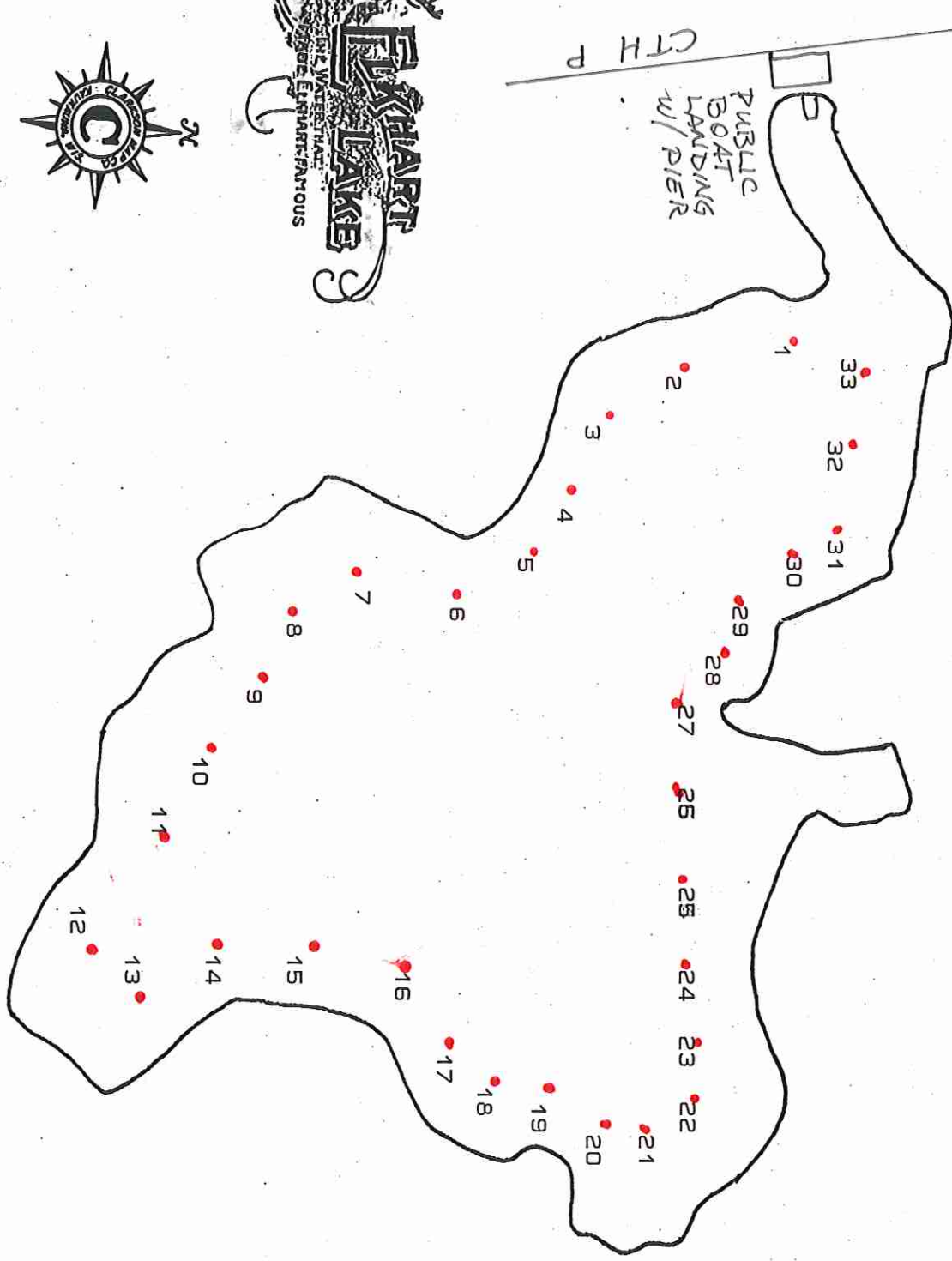

ORDINANCE NO. 370

The Village Board of the Village of Elkhart Lake, Wisconsin, does hereby ordain as follows:

That the following sections of the municipal code of the Village of Elkhart Lake, Wisconsin are hereby amended to read as follows:

That Section 7.03 of the Municipal Code of the Village of Elkhart Lake, Wisconsin, is hereby amended to read as follows:

SECTION 7.03. LOCAL REGULATIONS OF PROHIBITED OPERATION.

(1) That no person may operate a motor boat towing a person on water skis, aquaplane or similar device, and that no person may engage in water skiing, aquaplaning or similar activity, at any time from 7:30 p.m. to 10:00 a.m. except to the extent that such activities are prohibited by Sec. 30.69 (1) (a) Wisconsin Statutes.

(2) A speed of slow no wake speed is established at all hours for all boats operating on Big Elkhart Lake to the shoreside of no wake buoys designated as follows:

i. Buoy number One is located off the eastern shore at Camp Brosius and it is currently placed at 165 feet from the eastern shore of the camp.

ii. Buoy Number Two is located two hundred feet off the stone steps at Jack Van Der Vaart Residence.

iii. Buoy Number Three is located seventy five feet west of Hayssen's Boat House and two hundred and ten feet out from that point.

iv. Buoy Number Four is one hundred and sixty feet off of the Dempsey Boat House or off of the point the structure was originally built on

v. Buoy Number Five is current buoy located two hundred feet from shore at the point located northwest of the Freudenfeld property.

vi. Buoy Number Six is located two hundred feet off of the Freudenfeld structure that currently is a boat house.

vii. Buoy Number Seven is located two hundred feet off of the structure used to mount the pier at the Robert McIntyre cottage.

viii. Buoy Number Eight is a new buoy that will be located approximately three hundred and fifty feet off of the John Linnehan cottage.

ix. Buoy Number Nine is located east of Dr. Sellinger's deck area approximately one hundred and fifty feet to the east and to be located two hundred and fifty two feet from that location.

- x. Buoy Number Ten is located two hundred feet directly in front of the Leonard Gentine pier.
- xi. Buoy Number Eleven is located approximately one hundred and seventy five feet off of the William Thieman residence.
- xii. Buoy Number Twelve is located two hundred feet off of the shore of Lehey's cottage.
- xiii. Buoy Number Thirteen is located off of the Robert McComis cottage at a distance of three hundred feet directly in line with the Gary Dulmes cottage located on the southern shore of Sheboygan Bay.
- xiv. Buoy Number Fourteen is located directly off of the Ballhorn cottage almost directly in line with the Imig cottage directly across the lake.
- xv. Buoy Number Fifteen is located two hundred and fifty feet off of the Worm cottage.
- xvi. Buoy Number Sixteen is located two hundred feet off of the Gottsacker residence on the east shore of Elkhart Lake.
- xvii. Buoy Number Seventeen is located three hundred feet off of Sharp's point.
- xviii. Buoy Number Eighteen is a new buoy placed three hundred feet from the Point Elkhart Beach area.
- xix. Buoy Number Nineteen is located three hundred feet off of the Point Elkhart Condominium Point.
- xx. Buoy Number Twenty is located in a direct line equidistant between nineteen and twenty one.
- xxi. Buoy Number Twenty One is placed four hundred and twenty five feet off of the location where the Camp Harand Pier is attached to shore.
- xxii. Buoy Number Twenty Two is to be located three hundred feet off of Siebken's beach.
- xxiii. Buoy Number Twenty Three is located two hundred and fifty feet from the swimming pier located at Barefoot Bay Resort.
- xxiv. Buoy Number Twenty Four will be in a direct line with twenty three through twenty seven based upon the location of these buoys as stated.
- xxv. Buoy Number Twenty Five will be in line with buoy number twenty four, twenty six and twenty seven. There will be a direct line between these buoys.

xxvi. Buoy Number Twenty Six will be in direct line with buoy number twenty three through twenty seven based upon the placement of buoy twenty seven.

xxvii. Buoy Number Twenty Seven is located one hundred and twenty feet off of Imig Point.

xxviii. Buoy Number Twenty Eight will be located one hundred and sixty feet off of the Lee Verhulst shoreline. this distance is measured from the shore area where the pier meets the land.

xxix. Buoy Number Twenty Nine is located two hundred feet off of Bray's point.

xxx. Buoy Number Thirty is located two hundred feet off of the Dallenbach home located on Lakeshore Drive.

xxxi. Buoy Number Thirty One is located two hundred feet off of the Frank Rieder lake frontage.

xxxii. Buoy Number Thirty Two will be located three hundred and ten feet off the Harry Bremer boat house.

xxxiii. Buoy Number Thirty Three will be located three hundred and thirty feet off of the octagon house located on the point of Camp Brosius. This buoy is to be lined up with the flag-pole on the Walter Vollrath residence, which is located on the North shore of Elkhart Lake.

Buoys are numbered in conjunction with their location beginning at the outlet in a counter clockwise direction.

That Section 7.03 (3) of the Municipal Code of the Village of Elkhart Lake, Wisconsin, should be hereby repealed.

That Section 7.03 (4) of the Municipal Code of the Village of Elkhart Lake, Wisconsin, is hereby amended to read as follows and is to be renumbered as subsection (3):

(3) In the interest of public health and sanitation, no person shall occupy, or cause, or allow to be occupied, any houseboat, raft or other vessel upon the waters of Elkhart Lake, Crystal Lake and all other waters of the village of Elkhart Lake as a habitation. "Habitation" herein means using such vessel for housing overnight.

That Section 7.03 (5) of the Municipal Code of the Village of Elkhart Lake, Wisconsin is hereby amended to read as follows and is to be renumbered as subsection (4):

(4) A speed limit of slow no wake speed is established on all Village of Elkhart Lake waters between the hours of 7:30 p.m. and 10:00 a.m. except as prohibited by Wisconsin Statutes Sec 30.68.

That Section 7.03 (6) is hereby renumbered as subsection (5).

That Section 7.04 of the Municipal Code of the Village of Elkhart Lake, Wisconsin, is hereby amended to read as follows:

SECTION 7.04 SUNDAY OPERATION PROHIBITED.

(1) There shall be no power boating on Elkhart Lake, Little Elkhart Lake or Crystal Lake, during the hours of 12:01 a.m. to midnight on Sundays, beginning the second Sunday in June through and including the second Sunday in September of any year. Power boating is defined as any craft propelled by an electrical, gasoline, diesel or other type of motor.

(2) Commencing the second Sunday in June, 1989 and ending the third Sunday in September of 1989, craft propelled by electric motors and operated at slow no wake speeds shall be allowed on Elkhart Lake, Little Elkhart Lake and Crystal Lake at all times. In October, 1989, a public hearing shall be held for the purpose of considering whether this subsection should be extended and whether such extension is consistent with Chapter 30, Wisconsin Statutes as to Public Health, Safety or Welfare. This subsection shall expire unless reenacted subsequent to the public hearing.

That Section 7.05 of the municipal code of the Village of Elkhart Lake, Wisconsin, is hereby amended to read as follows:

SECTION 7.05 ENFORCEMENT

The Elkhart Lake Police Department pursuant to contract with the Town of Rhine will provide law enforcement services and will patrol Elkhart Lake and Little Elkhart Lake and enforce all sections relating to boating and boating activities. Enforcement of this Chapter on Crystal Lake will also be provided by the Village of Elkhart Lake Police Department pursuant to said contract with the Town of Rhine. Said contract provides for an annual sum to be paid by the Town of Rhine to the Village of Elkhart Lake for said services. The officers patrolling and enforcing these sections shall be hired and under the control of the Elkhart Lake Chief of Police and Village Board of Elkhart Lake.

That Section 7.06 of the municipal code of the Village of Elkhart Lake, Wisconsin, is hereby amended as follows:

SECTION 7.06 PENALTY

Any person who shall violate any of the provisions of this chapter shall be subject to the penalties of Wisconsin Statutes 30.80 which is hereby adopted by reference.

SECTION 7.07 JURISDICTION

It is expressly understood that the jurisdiction over the waters of Big Elkhart Lake is jointly held by the Town of Rhine and the

Village of Elkhart Lake. It is further understood that jurisdiction over the waters of Crystal Lake is jointly held by the Town of Rhine and Town of Plymouth.
