

ORDINANCE 87-2

An ordinance to regulate water traffic, boating and water sports upon the lagoons located in the Harmony Grove development in the Town of Lodi.





The Town Board of the Township of Lodi, Columbia County, Wisconsin, does ordain the following:

2-87.01. Intent:

The intent of this ordinance is to provide safe conditions for the enjoyment of acquatic recreation and to reduce the destruction of shoreline consistent with public rights and interest and the capability of the water resource.

2-87.02. Applicability and Enforcement:

The provisions of this ordinance shall apply to the waters known as "the lagoons" located in Harmony Grove within the jurisdiction of the Town of Lodi. The provisions of this ordinance shall be enforced by the supervisors of the Town Board of the Town of Lodi.

2-87.03. State Boating and Water Safety Laws Adopted:

The statutory provisions describing and defining regulations with respect to water traffic, boats, boating and related water activities and safety in the following enumerated sections of the Wisconsin Statutes, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of said statutes, are hereby adopted and by reference made a part of

this ordinance:

2-87.04. Definitions:

- (1) "Shore zone" means all surface water within 200 feet of the shoreline.
- (2) "Swimming zone" means an authorized area marked by regulatory markers to designate a swimming area.
- (3) "Public access" means any access to the water by means of public property.
- (4) "Slow-no-wake" means the slowest possible speed so as to maintain steerage.

2-87.05. Speed Restrictions:

"Slow-no-wake" signs shall be posted in "the lagoons" of Harmony Grove for the protection of public health, safety and welfare. Violators shall be prosecuted to the full extent of the law as provided in Sec. 30.80 of Wis. Stat.

2-87.06. Separability of Provisions:

Should any section or provision of this ordinance be declared invalid, such decisions shall not affect the validity of the remaining portions of this ordinance.
