AMENDMENT TO ORDINANCE NO. 1991-2 BOATING ORDINANCE

The Town Board of Stephenson, Marinette County, Wisconsin does ordain that Ordinance No. 1991-2, previously adopted on June 26, 1991, is hereby amended as follows:

Addition to Section 6. Restricted Areas

F. No person may operate a motorboat at a speed in excess of slow-no-wake in that portion of the High Falls Flowage which is located south of Boat Landing 7 and known locally as the North Narrows, as marked by regulatory slow-no-wake buoys.

Additional Section.

Section 11. Water Skiing. A water ski pickup and drop area is hereby established, pursuant to Wisconsin Statutes 30.69(3), in that portion of the High Falls Flowage located adjacent to the High Falls Park, marked with regulatory markers and described as follows:

Part of Section 31, T33N-R19E and Section 36, T33N-R18E all in the Town of Stephenson, Marinette County, Wisconsin described as:

Commencing at the North Quarter Corner of said Section 31, as marked by a 60 penny spike, 6 feet east of the center line of Boat Landing "3" Road; thence N89018'53"W along the north line of said Section 31, 38.90 feet to a 3/4 inch rod on the westerly right-of-way of said road; thence along a curve to the right, Radius of 1008.74 feet and Long Chord that bears S13047'40"W 268.80 feet to a 3/4 inch rod; thence S21027'04"W along said right-of-way, 1392.20 feet to a 1 inch pipe; thence N88010'41"W 193.18 feet to a 1 inch pipe on the shore of High Falls Reservoir; thence along a meander line, straight line bearing N88039'59"W 823.13 feet to a 1 inch pipe at the point of beginning of this description; thence S15058'21"W across the mouth of a bay, 351.97 feet to a 1 inch pipe; thence meandering the water edge, straight line bearing of S51021'10"W 1290.54 feet to a 1 inch pipe; thence meandering the waters edge, straight line bearing of S77026'33"W 2159.18 feet to a 1 inch pipe; thence NO8048'57"E across said Reservoir, 1951.32 feet to a 60 penny spike on an island hereon known as Chocolate Drop; thence \$69055'54"E 1895.87 feet to a 1 inch pipe on the southern most point of an island hereon known as . Seahorse Island; thence meandering the waters edge of said island, straight line bearing N25026'45"E 700.33 feet to a 1 inch pipe; thence N71038'36"E across said Reservoir, 232.25 feet to a 1 inch pipe; thence meandering the waters edge, straight line bearing S58050'48"E 714.15 feet to the 1 inch pipe at the point of beginning.

Change to Section 10. Severability.

The word hereinabove (word 2, line 2) of this section is changed to herein.

Condition Report

Pertaining to Section 6. Restricted Areas.

F. Slow-no-wake area is proposed in that portion of the Peshtigo River (High Falls Flowage) downstream from Boat Landing 7 because this area is a narrowing of the river, thereby constricting boat traffic and rendering the area dangerous when a number of boats are navigating through it, at the same time, at a speed in excess of slow-no-wake. Many users have contacted town officials requesting a slow-no-wake zone due to potential hazards caused by many near misses between themselves and others.

Pertaining to Section 11. Water Skiing.

This area is proposed to be used by the public in general who may wish to pickup and drop off skiers at docks and a ski jump, and by a ski team for the same purposes, pursuant to Wisconsin Statutes 30.69(3), and to alert other users in the area that they may expect water skiing activities to be occurring in the established area. Ski shows and ski practices will also take place in this area.
