AN ORDINANCE TO REGULATE BOATING UPON THE WATERS LOCATED IN THE TOWN OF STEPHENSON, CALDRON FALLS FLOWAGE, HIGH FALLS FLOWAGE, JOHNSON FALLS FLOWAGE, LEFT FOOT LAKE, BIG NEWTON LAKE, LITTLE NEWTON LAKE, SANDSTONE FLOWAGE AND THUNDER LAKE, AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

The Town Board of the Town of Stephenson, Marinette County, Wisconsin does ordain as follows:

Section I. Intent. The intent of this ordinance is to provide healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest and the capability of the water resource.

Section II. Applicability and Enforcement. The provisions of this Ordinance shall apply to the waters of Caldron Falls Flowage, High Falls Flowage, Johnson Falls Flowage, Left Foot Lake, Big Newton Lake, Little Newton Lake, Sandstone Flowage and Thunder Lake within the jurisdiction of the Town of Stephenson. The provisions of this ordinance shall be enforced by the Town Constables or other persons or agencies authorized by the Town Board of the Town of Stephenson.

Section III. State Boating and Safety Laws Adopted. State boating laws as found in SS. 30.50 to 30.71 are adopted by reference.

Section IV. Motor Boat Restricted Area - Rock Buoy. No person may operate a motor boat at a speed greater than slow-no-wake as defined in 30.50 (6) Wisconsin Statutes on the waters of High Falls flowage within 100 feet of said water marked by Rock Buoys located in T32N R18E Section 1; 660 feet from east edge of dam, 675 feet from far east edge dyke in the Town of Stephenson, Marinette County, Wisconsin.

Section V. Penalties. Wisconsin state boating penalties as found in s. 30.80 are adopted by reference.

Section VI. Severability. In the event that any section or sections here in above shall be ruled unconstitutional, by any competent court, such determination shall not affect the validity or effectiveness of the other sections of this ordinance, and the remainder of said ordinance shall remain in full force and effect.

The foregoing ordinance is hereby adopted by the Town Board of the Town of Stephenson on this 13 day of October, 1999.

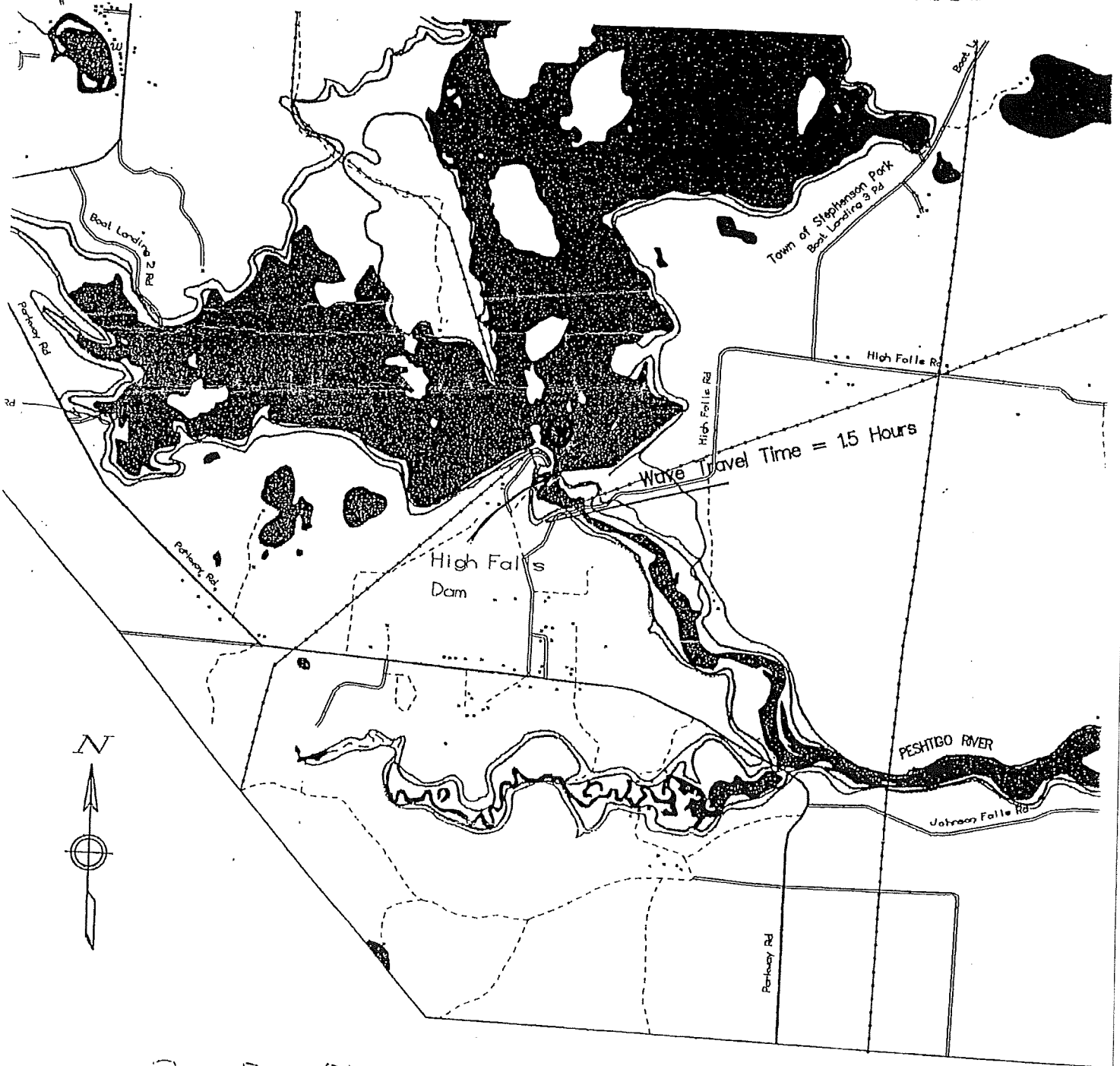
