

**AN ORDINANCE TO REGULATE BOATING UPON THE WATERS OF LAKE NOQUEBAY AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.**

The Town Board of the Town of Lake, Marinette County, Wisconsin, do ordain as follows:

**SECTION I. Applicability and Enforcement.**

- (a) The provisions of this Ordinance shall apply to the waters of Lake Noquebay.
- (b) This chapter shall be enforced by the officers of the Town of Lake.

**SECTION II Intent**

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.

**SECTION III State Boating and Safety Laws Adopted**

State boating laws as found in ss. 30.50 to 30.71, Wis. Stats., are adopted by reference.

**SECTION IV Water Skiing Pick Up and Drop Zone**

- (a) **Establishment of Ski Pick-up/Drop Areas.** A water Ski Pick-up/Drop Area is hereby established, pursuant to Section 30.69(3), Wis. Stats., in that portion of Lake Noquebay adjacent to the boat dock located at Lake Noquebay County Park and adjacent to the boat dock located at John Scheel's property being W6840 Lakeview Road which is parcel #016-00636.004 lot #1 CSM 1105 in V7 PG212 BNG PRT GOVT LOT 2 S7 T32N R21E SUBJ TO & W/ESMT IN 6015J1. The Ski Pick-Up/Drop Area shall be defined as an area no more than one hundred (100) feet from the location on the Lake Noquebay County Park boat dock and John Scheel's boat dock that the regulatory markers are affixed.
- (b) **Regulatory Marker.** The Ski Pick-Up/Drop Area hereby established will only be in effect when an appropriate regulatory markers are affixed to the dock located at Lake Noquebay County Park and/or John Scheel's property being W6840 Lakeview Road which is parcel #016-00636.004 lot #1 CSM 1105 in V7 PG212 BNG PRT GOVT LOT 2 S7 T32N R21E SUBJ TO & W/ESMT IN 6015J1. A regulatory marker shall be an appropriately sized sign that is white in color with three (3) inch black letters and a three (3) inch orange border around the perimeter of the sign. The sign shall state "Ski Pick-Up/Drop Area".
- (c) **Dates and Times.** The Ski Pick-Up/Drop Area shall only be in effect during official Crivitz Ski-Cats practices and/or performances and shall only be utilized by members of the Crivitz Ski-Cats. No other person, firm or organization shall be entitled to utilize "Ski Pick-Up/Drop Area" regulatory marker or operate within one hundred (100) feet of a dock at a speed in excess of slow-no-wake

**SECTION V Posting Requirements**

The Town of Lake shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town of Lake pursuant to the requirements of NR 5.15 Wis. Admin. Code.

**SECTION VI Penalties**

Wisconsin state boating penalties as found in Wis. Stat 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.

**SECTION VII Severability**

The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

**SECTION VIII Effective Date**

This section will become effective upon passage and the day after publication.
