Town of Upham Ordinance # 5

An ordinance to regulate boating upon the waters of Indian and Snag Lake, Upham Township, Langlade County, Wisconsin and prescribing penalties for violation thereof.

The Town Board of the Town of Upham, County of Langlade, Wisconsin, do ordain as follows:

Section 1: Applicability and Enforcement.

The provisions of this ordinance shall apply to the entire waters of Indian and Snag Lake, within the jurisdiction of the Town of Upham, County of Langlade, Wisconsin. The provisions of this ordinance shall be enforced by the law enforcement offices of the Town of Upham, along with any and all other state and county offices authorized by law to enforce the same.

Section 2: Gasoline Powered Boats Prohibited.

All gasoline powered boats are prohibited at all times on these lakes. Boats with electric powered motors will be permitted.

Section 3: Penalties and Deposits.

Any person who shall violate the provisions adopted by this ordinance shall, upon conviction thereof, forfeit not less than \$10, nor more than \$50, together with the costs of prosecution.

This ordinance shall be in full force and effect from after publication.
