ORDINANCE #1996-4

AMENDMENT TO ORDINANCE #1-1984 REGULATING
WATER TRAFFIC, BOATING AND WATER SPORTS UPON THE WATERS
OF THE TOWN OF SPRINGWATER AND PRESCRIBING PENALTIES
FOR VIOLATION THEREOF

WHEREAS, the Town Board of the Town of Springwater, Waushara County, State of Wisconsin, did enact Ordinance #1-1984 regulating water traffic, boating and water sports upon the waters of the Town of Springwater, Waushara County, Wisconsin, and

WHEREAS, the Town Board of the Town of Springwater has been requested by the Gilbert Lake Advancement Association to create a slow-no-wake area in the eastern bay of Gilbert Lake, which includes the location of the public access, and

WHEREAS, the Gilbert Lake Advancement Association has agreed to purchase, install and maintain the buoys needed to mark the slow-no-wake area, and

WHEREAS, the Department of Natural Resources has approved the Waterway Marker Application.

IT IS THEREFORE ORDERED THAT Section VII. RESTRICTIONS - SPECIFIC TO PARTICULAR WATERS LOCATED IN THE TOWN OF SPRINGWATER, Paragraph (a) GILBERT LAKE, sub-paragraph (3) of the aforementioned ordinance #1-1984 be created to read as follows:

(3) No Wake Zone

No person shall operate a boat of any nature in excess of a slow-no-wake speed on these specific waters of Gilbert Lake which includes the portion of the eastern bay in Gilbert Lake that extends from the public landing located on 23rd Road, Section 14, to a demarcation line, running due north to south, at a distance of approximately 700 feet west of the shoreline at the aforementioned public landing, described more particularly as that area of Gilbert Lake which lies east of a line beginning at a point described as the Murphy Boat House located on parcel no. 032-1171-0200, W5517 N. Gilbert Lake Road, Lot 2, Gilbert Lake Summer Resort, proceeding southerly and ending at a point described as the Bramley Boat House located on parcel no. 032-1471-4700, W5530 S. Gilbert Lake Road, Lots 47 and 48, Gilbert Park Manor Subdivision. The area shall be marked by buoys, approved by the United States Coast Guard as well as the Department of Natural Resources. Said buoys will be purchased, installed, removed and maintained by the Gilbert Lake Advancement Association.

In all other respects, Ordinance #1-1984 is hereby republished, ratified and confirmed.
