Boating Safety

AN ORDIFIANCE TO ESTABLISH A SLOW-NO-WAKE AREA PURSUANT TO SECTION 30.77 OF THE WISCONSIN STATUTES.

The Town Board of the Town of Garfield, Wisconsin do ordain as follows:

- Section 1. Intent. The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistant with public rights and interest and the capability of the water resource.
- Section 2. Applicability and Enforcement. The provisions of this ordinance shall apply to the waters of Lake Wapogasset and Bear Trap lakes within the jurisdiction of the town of Garfield. The provision of this ordinance shall be enforced by the officers of the town of Garfield and the Polk County Sheriff's department.
- Section 3. Definition
 - a. Slow-no-wake shall be defined as the slowest possible speed so as to maintain steerage.
- Section 4. Penalties. Any person violating this ordinance shall forfeit not more than \$50 for the first offense and shall forfeit not more than \$100 upon conviction of the same offense a 2nd or subsequent time within a year.
- Section 5. Effective date. This ordinance shall take effect and be in force from and after its passage and posting as provided by law.

ORDINANCE

No person shall operate a motor boat at a speed greater than slow-no-wake within the marked area of the channel between Bear Trap and Wapogasset lakes, located in Section 25, Township 33 North, Range 17 West, in Polk County.


