

ORDINANCE # 1985-1

AN ORDINANCE AMENDING ORDINANCE #1983-1 REGULATING WATER TRAFFIC, BOATING AND WATER SPORTS UPON THE WATERS OF PLEASANT LAKE, LOCATED IN THE TOWN OF COLOMA AND THE TOWN OF SPRINGFIELD, AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF:

WHEREAS, the Town Board of the Town of Coloma, Waushara County, Wisconsin, and the Town Board of the Town of Springfield, Marquette County, Wisconsin, did enact Ordinance #1983-1 regulating water traffic, boating, and water sports on Pleasant Lake located in the Towns of Coloma and Springfield, and

WHEREAS, the Town Boards of the Towns of Coloma and Springfield have been directed by the Wisconsin Department of Natural Resources to amend said ordinance.

IT IS THEREFORE ORDAINED that Section 8 of the aforementioned Ordinance #1983-1 be amended to read as follows:

Section 8. Penalties.

1. Any person violating any provision of this ordinance shall forfeit not more than \$50.00 for the first offense and shall forfeit not more than \$100.00 upon conviction of the same offense a second or subsequent time within one year.
2. The operator of a duly authorized patrol boat, when in pursuit of an actual or suspected violator of the law, need not comply with the regulations fixing maximum speed or direction of traffic flow.

IT IS ALSO ORDAINED that Sections 9 and 10 be added to Ordinance #1983-1 to read as follows:

Section 9. Severability:

All ordinances regulating water traffic, boats, boating or water sports upon the waters covered by this ordinance and all ordinances or parts of ordinances in conflict with this ordinance heretofore enacted by the Town of Coloma, Waushara County, Wisconsin, and the Town of Springfield, Marquette County, Wisconsin, are hereby repealed.

Section 10. Effective Date: Clerk's Duty:

- (a) This ordinance shall take effect and be in force from and after passage, publication and posting as provided by law.
- (b) The Town Clerks are directed to file a copy of this ordinance with the Wisconsin Department of Natural Resources in Madison, Wisconsin.

In all other respects, Ordinance #1983-1 is hereby republished, ratified and confirmed.
