BOATING - SQUAW, BUCKSKIN, SHISHEBOGAMA AND SQUIRREL LAKE

204.000 A joint ordinance to regulate water traffic boating and water sports upon the waters of Squaw Lake, Buckskin Lake, Shishebogama Lake and Squirrel Lake, which are in the jurisdiction of the Town of Minocqua, Oneida County, Wisconsin, and the Town of Lac Du Flambeau, Vilas County, Wisconsin.

204.001 Enforcement:

(a) The provisions of the ordinance shall be enforced by the Officers of the Minocqua and Lac Du Flambeau Boat Patrol and Police Department.

204.002 The Town Boards of the Town of Minocqua, Oneida County, Wisconsin, and the Town of Lac Du Flambeau, Vilas County, Wisconsin, do ordain as follows.

204.003 Intent:

(a) The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest and the capability of the water resource.

204.004 State Boating and Safety Law Adopted:

(a) State Boating Laws as found in Wisconsin Statutes 30.50 to 30.71 and 30.80, are adopted by reference.

204.005 Restricted Hours for Water Skiing on Certain Lakes:

(a) No person shall ~~water ski~~ ^{operate a motorboat in excess of} between the hours of ~~8:00 PM and 9:00 AM~~ ^{"Slow-No-wa"} on Squaw Lake, Buckskin Lake and Shishebogama Lake. ~~local time~~

204.006 Special Events:

(a) There shall be no organized water events, special events, or contests without the express permission of the Town Boards of Minocqua and Lac Du Flambeau.

204.007 Penalties:

- (a) Wisconsin State Boating Penalties as found in Wisconsin Statutes 30.80 are adopted by reference.

204.008 Severability:

- (a) The provisions of this ordinance shall be deemed severable and it is expressly declared that the Minocqua and Lac Du Flambeau Town Boards would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.
