

ORDINANCE 2007-01
NO-WAKE RESTRICTION IN CHANNEL OF TIGER CAT LAKE,
TIGER CAT DAM BOAT RAMP AREA

A SOLE ORDINANCE TO REGULATE BOATING UPON THE WATERS OF TIGER CAT LAKE CHANNEL ADJACENT TO TIGER CAT DAM BOAT LANDING AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

The Board of Supervisors of the Town of Round Lake do ordain as follows:

Section I. APPLICABILITY AND ENFORCEMENT

- a.) The provisions of this Ordinance shall apply to the waters of Tiger Cat Lake, Channel (two zones). GPS co-ordinates:

Zone near boat landing:

Buoy #1 N46 1.741 W91 14.656

Buoy # 2 N46 1.768 W91 14.684

Zone at narrows to the bay:

Buoy #3 N46 1.843 W91 14.715

Buoy #4 N46 1.917 W91 14.743

- b.) This chapter shall be enforced by Sawyer County or any officer of the Town of Round Lake appointed by the Board of Supervisors of the Town of Round Lake.

Section II. INTENT

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest, and the capability of the water resources.

Section III. STATE BOATING AND SAFETY LAW ADOPTED.

State boating laws as found in ss.30.50 to 30.71, Wis. Stats., are adopted by reference.

Section IV. DEFINITIONS

- a.) "Slow-no-wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.

Section V. CONTROLLED AREA

No person shall operate a boat faster than slow-no-wake in the water of Tiger Cat Lake (Dam Channel) within the following zones at any time. (Map Attached)

Zone near boat landing: GPS co-ordinates

Buoy #1 N46 1.741 W91 14.656

Buoy # 2 N46 1.768 W91 14.684

Zone at narrows to the bay: GPS co-ordinates

Buoy #3 N46 1.843 W91 14.715

Buoy #4 N46 1.917 W91 14.743

Section VI. POSTING REQUIREMENTS

The Town of Round Lake shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town of Round Lake pursuant to the requirements of NR 5.15 Wis. Admin Code.

Section VII. PENALTIES

Wisconsin state boating penalties as found in Wis Stat. 30.80, and deposits as established in the uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.

Section VIII. SEVERABILITY



If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

This section will become effective upon passage and the day after publication.






