WHITE LAKE MANAGEMENT DISTRICT ORDINANCE 98-1

AN ORDINANCE TO CREATE AN ORDINANCE TO REGULATE WATER TRAFFIC, BOATING AND WATER SPORTS UPON THE WATERS OF WHITE LAKE AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

The Board of Commissioners of the White Lake Management District, Towns of Montello and Mecan, Wisconsin do ordain as follows:

Section 1. *Intent*. The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest and the capability of the water resource.

Section 2. Applicability and Enforcement. The provisions of this ordinance shall apply to the waters of White Lake within the jurisdiction of the White Lake Management District.

Section 3. State Boating and Water Safety Law Adopted. The statutory provisions describing and defining regulations with respect to water traffic, boats, boating and related water activities and safety in the following enumerated sections of the Wisconsin Statutes, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of said statutes, are hereby adopted and by reference made a part of this ordinance.

Section 4. Definitions in this ordinance:

- (a) "Shore line" means all surface water within 200 feet of the shore line.
- (b) "Swimming zone" means an authorized area marked by regulatory markers to designate a swimming area.
- (c) "Designated anchorage" means an area of water established and marked as an anchorage by lawful authority.
- (d) "Public access" means any access to the water by means of public property.
- (e) "Navigation lane' means an area designated by authorized aids to navigation.

(f) "Slow-no wake" is defined as the slowest possible speed so as to maintain steerage.

Section 5. Motor Boats and Safety

- (a) Definition. Definitions contained in Section 30.50 of the Wisconsin Statutes are adopted and made a part hereof by reference.
- (b) The use and/or operation of outboard motor and inboard motor having a rated capacity in excess of 70 H.P. is hereby prohibited.
- (c) The operator of a boat overtaking and passing another boat shall keep to the left of such boat overtaken and passed.
- (d) No person shall operate a boat upon the waters of White Lake at a speed in excess of 10 MPH or Slow No Wake, whichever is more restrictive, except that speeds in excess of 10 MPH shall be allowed on Fridays and Saturdays from 10:00 a.m. to 8:00 p.m. and Sunday through Thursday from 10:00 a.m. to 8:00 p.m.
- (e) Water skiing, surf-boarding, aquaplaning, and towing of any device upon the lake, other than emergency towing of a boat in distress, shall be prohibited rom 8:00 p.m. to 10:00 a.m., except that water skiing, surfing and aquaplaning shall be permitted from 10:00 a.m. to 6:00 p.m. on Sunday through Thursday, and 10:00 a.m. to 8:00 p.m. on Fridays and Saturdays.
- (f) A person operating a motorboat having in tow a person on water skis, aquaplane or floating device shall operate such boat in a careful and prudent manner and at a reasonable distance from persons and property so as not to endanger the life or property of any person.
- (g) No person shall drop a ski in "one ski" water skiing except immediately in front of the land shore property from which he is skiing.
- (h) All floating rafts and piers shall be beached or moored immediately adjacent to the beach from sunset to sunrise.
- No person shall sit on the gunwales or on the backs of the seats in the boat while the boat is moving.

Section 5. Penalties. Any person, firm or corporation violating this ordinance shall be fined not more than \$50.00 or imprisoned more than 30 days, or both, for the first offense, and fined not more than \$100.00 or imprisoned not more than 90 days, or both, upon conviction of the same offense a second or subsequent time within one year.

Section 7. Severability. If any section or subsection or clause of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other sections or subsections or applications of this ordinance which can be given effect without the invalid section or subsection or application, and to this end the provisions of this ordinance are declared to be severable.

Section 8. Effective Date. This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
