A SOLE ORDINANCE TO REGULAR BOATING UPON THE WATERS OF ENTERPRISE LAKE AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

The Town Board of the TOWN OF ELCHO do ordain as follows:

SECTION 1. APPLICABILITY AND ENFORCEMENT

(A)The provisions of this Ordinance shall apply to the waters of ENTERPRISE LAKE (B)This chapter shall be enforced by the TOWN OF ELCHO, LANGLADE COUNTY SHERIFF, or any LAW ENFORCEMENT AGENCY having jurisdiction over the waters of Enterprise Lake

SECTION II INTENT

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of. aquatic recreation consistent with public rights and interests, and the capability of the water resources. Specifically, to protect

the aquatic vegetation, shoreline and shoreline vegetation and waterfowl production in these three shallow bays, and the shallow waters surrounding the island.

SECTION III STATE BOATING AND SAFETY LAWS ADOPTED

State boating laws as found in ss. 30.50 to 30.71, Wis, Stats., are adopted by reference.

SECTION IV DEFINITIONS

(A) "Slow-no-wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.

SECTION V CONTROLLED AREA

No person shall operate a boat faster than slow-no-wake in the waters of ENTERPRISE LAKE:EAST BAY, OUTLET BAY, AND THE BAY WEST, SOUTH, and NORTH OF THE ISLAND, and from the MAINLAND POINT NORTH OF THE ISLAND FOLLOWING THE 10 FOOT DEPTH CONTOUR TO THE BOAT LANDING, as marked on the map at the public access landing and/or no wake buoys.

SECTION VI POSTING REQUIREMENTS

The ENTERPRISE LAKE PLANNING AND REHABILITATION DISTRICT maintain a synopsis of this ordinance at all public access points within the jurisdiction of the DISTRICT ON ENTERPRISE LAKE pursuant to the requirements of NR 5.15 Wis. Admin. Code.

SECTION VII PENALTIES

Wisconsin state boating penalties as found in Wis. Stat. 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.

SECTION VIII SEVERABILITY

The provisions of this Ordinance shall be deemed severable and it is expressly declared that the TOWN BOARD would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

SECTION IX EFFECTIVE DATE

This section will become effective upon passage and the day after publication Passed this 4th day of April, 2002.
