

A SOLE ORDINANCE TO REGULATE BOATING UPON THE WATERS OF LAKE NOKOMIS,
TOWN OF NOKOMIS, ONEIDA COUNTY, WISCONSIN, AND PRESCRIBING PENALTIES FOR
THE VIOLATION THEREOF

The Town Board of the Town of Nokomis, Oneida County, Wisconsin, do ordain as follows:

I. Applicability and Enforcement:

A. The provisions of this ordinance shall apply to the waters of Lake Nokomis.

B. This chapter shall be enforced by the officers of the Town of Nokomis, Oneida County, Wisconsin, and by the officers of Oneida County, Wisconsin, and by any duly authorized law enforcement officer.

II. The intent of this ordinance is to provide for safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capacity of the water resources.

III. State Boating and Safety Laws Adopted.

State Boating Laws as found in Sections 30.50 to 30.71, Wisconsin Statutes, are adopted by reference.

IV. Definitions.

A. "Slow, No-Wake" means the speed at which a boat moves as slowly as possible while still maintaining steering control.

V. Controlled Area.

No person shall operate a boat faster than slow, no-wake, in the following waters of Lake Nokomis:

A. At the County Trunk Highway L bridge in an area defined as follows:

From a point east of the bridge marked by a line drawn as follows: Commencing at the northerly-most corner between Lots 23 and 24, Plat of Cozy Point, the place of beginning; thence northwesterly to the southerly-most corner of Lots 5 and 6, Plat of Indian Pine Point, the ending of the line, all in Section 35, Township 36 North, Range 6 East, the easterly boundary of the no wake zone, to a point 500 feet west of the county trunk highway bridge, the westerly boundary of the no-wake zone.

B. Beginning 300 feet east of the County Trunk Highway N bridge and ending 300 feet west of the County Trunk Highway N bridge.

VI. Posting Requirements.

The Town of Nokomis shall place and maintain a copy of this ordinance at all public access points within the jurisdiction of the Town.

VII. Penalties.

Wisconsin State Boating Penalties as found in section 30.80, Wisconsin Statutes, are adopted by reference.

VIII. Severability.

The provisions of this ordinance shall be deemed severable and it expressly declared that the Town Board would have passed other provisions of this ordinance regardless of whether or not one or more provisions may be declared invalid. If any provisions of this ordinance or the application to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provisions to other persons and circumstances shall not be affected.

IX. Effective Date.

This ordinance will become effective upon passage and the day after publication.
