## SECTION 1: TITLE

An Ordinance to regulate water traffic, boating and water sports upon the waters of that portion of Lake Alice and the Wisconsin River, within the Town's boundaries and jurisdiction which are located 300 (three hundred) feet north and 300 (three hundred) feet south of the County Highway "A" bridge; and prescribing penalties for violation thereof.

## SECTION 2: REPEAL

The following ordinance shall supersede all prior ordinances relative to the above subject.

## SECTION 3: EFFECTIVE DATE

The following ordinance shall become effective upon passage and the day after publication.

SECTION 4-1: "Slow-no-wake" Regulations: Lake Alice and the Wisconsin River.

(a) Purpose: To provide for safe and healthful conditions for the enjoyment of aquatic recreation consist with public rights and interest, and water resource capability.

(b) Applicability and Enforcement: Provisions of this ordinance shall apply to the waters of that portion of Lake Alice and the Wisconsin River lying 300 (three hundred) feet north and 300 (three hundred) feet south of the County Highway "A" bridge of the Town of King and shall be enforced as authorized by the Board of Supervisors of the Town of King.

(c) State Boating and Safety Laws Adopted: Wisconsin Statutes, Sections 30.50 through 30.71, inclusive, are adopted by reference.

(d) Definition: "Slow-no-wake" shall mean that speed at which a motorized water craft or boat moves as slowly as possible while still maintaining steerage control.

(e) Regulated Areas: All "slow-no-wake" areas shall be designated by buoys meeting Wisconsin Administrative Code standards, NR 5.09. The "slow-no-wake" shall be located on that portion of Lake Alice and the Wisconsin River lying 300 (three hundred) feet north and 300 (three hundred) feet south of the County Highway "A" bridge of the Town of King, Lincoln County, Wisconsin.

(f) Posting Requirements: The Town of King shall place and maintain a synopsis of this ordinance at all public access points on Lake Alice and that portion of the Wisconsin River within the jurisdiction of the Town of King pursuant to the requirements of NR.5.15 Wisconsin Administrative Code.

(g) Penalties: Wisconsin state boating penalties as found in Wis. Stat. 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment are deleted.

(h) Severability: The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town of King Board would have passed other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.
