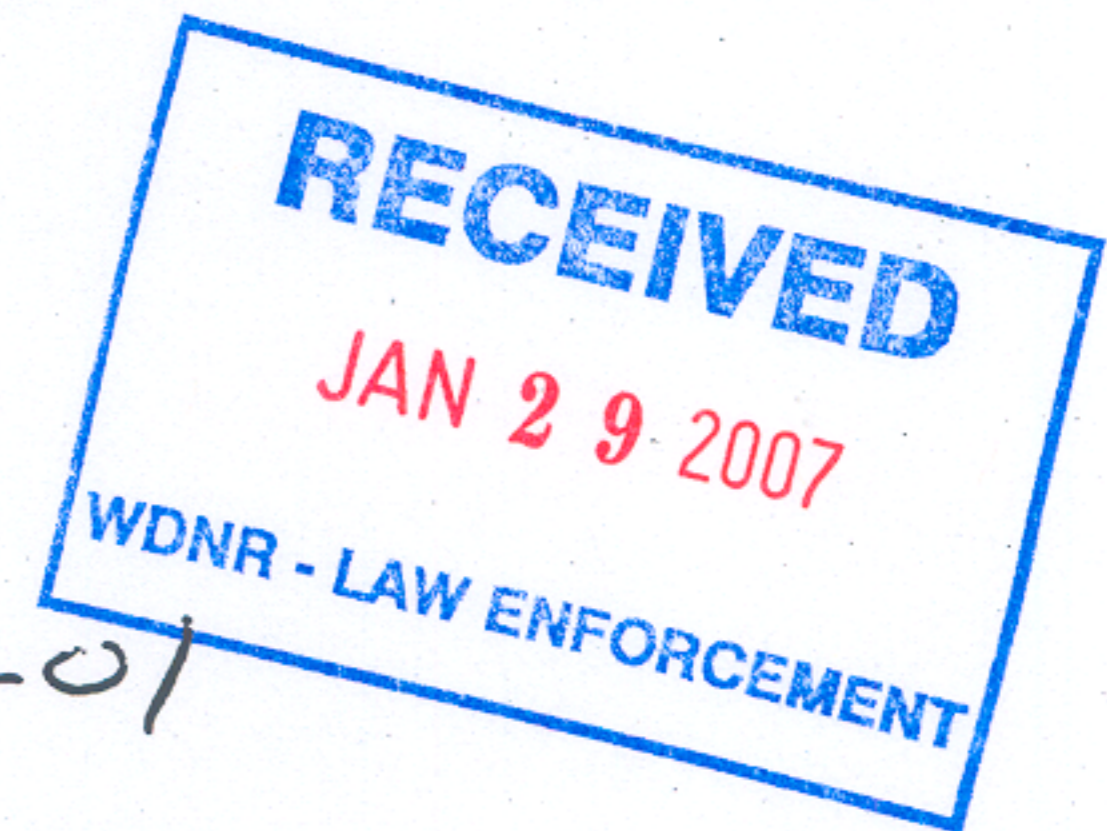

ORDINANCE SG-07-01-01

AN ORDINANCE TO REGULATE BOATING UPON THE WATERS OF THE TOWN OF SAINT GERMAIN IN VILAS COUNTY, WISCONSIN AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

The Saint Germain Town Board of the County of Vilas does ordain as follows:

Section I. **Applicability and Enforcement**

- 1) The provisions of this Ordinance shall apply to the waters specified in Section IV of this Ordinance.
- 2) This chapter shall be enforced by the officers of the Town of Saint Germain and any other authorized law enforcement officer.

Section II. **Intent**

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.

Section III. **State Boating and Safety Laws Adopted**

State boating laws as found in ss.30.50 to 30.71, Wisconsin Statutes, are adopted by reference.

Section IV. **Motor Boat Prohibited Area**

No person shall operate a motorboat, as defined in 30.50(6), Wisconsin Statutes, that is propelled by internal combustion engine or engines on Little Bass Lake (T40N, R8E, S15). Electric motors only are permitted on said waters.

Section V. **Posting Requirements**

The Town of Saint Germain shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town pursuant to the requirements of NR 5.15, Wisconsin Administrative Code.

Section VI. **Penalties**

Wisconsin state boating penalties as found in Wisconsin Statute 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.

Section VII. Severability



If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.


Section VIII. Effective Date


This ordinance will become effective upon passage and the day after publication.




