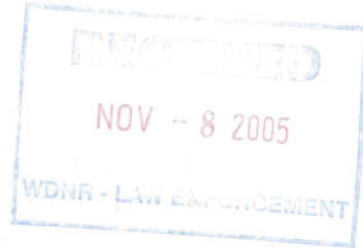

SLOW NO WAKE AREA



A SOLE ORDINANCE TO REGULATE BOATING UPON THE WATERS OF SOLBERG LAKE IN THE AREAS KNOWN AS SQUAW CREEK AND COMFORT COVE BAY AND PRESCRIBING PENALTIES FOR VIOLATIONS THEROF.

The Town Board of the Town of Worcester, Price County, State of Wisconsin do ordain as follows:

Section I. **Applicability and Enforcement**

- (a) The provisions of this Ordinance shall apply to the waters of Solberg Lake in the areas known as Squaw Creek and Comfort Cove Bay located in the Town of Worcester, Price County, State of Wisconsin.
- (b) This chapter shall be enforced by the officers of the Town of Worcester.

Section II. **Intent**

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest, and the capability of the water resources.

Section III **State Boating and Safety Laws Adopted**

State boating laws as found in ss. 30.50 to 30.71, WI. Stats., are adopted by reference.

Section IV **Definitions**

- (a) "Slow-no-wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.

Section V **Controlled Area**

No person shall operate a boat faster than slow-no-wake in the waters of Solberg Lake in the areas known as Squaw Creek (1. From the Northwest corner of the shore where Squaw Creek becomes Solberg Lake. Go 140' East, approximate center(2. Then 60' South. From that point go 800' North and from the West shore go 90' East, approximate center(3. From the North side of the culvert on Solberg Lake Rd go 190' North and then from the East shore go 75' West, approximate center.

Comfort Cove Bay-Go 126' N from Comfort Cove Point. This will be the Center of the channel into Comfort Cove. Then go 50' NW from the center Point. This is the location of the broy.

Section VI **Posting Requirements**

The Town of Worcester shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town pursuant to the requirements of NR 5.15 WI Admin. Code.

Section VII **Penalties**

Wisconsin state boating penalties as found in WI Stat. 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all reference to imprisonment deleted.


Section VIII **Severability**

The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance respective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.


Section IX **Effective Date**
