

ORDINANCE NO. 269

AN ORDINANCE TO CREATE SECTION No. 9.4 OF THE CODE OF ORDINANCES, CITY OF ONALASKA, Wisconsin ENTITLED "BOATING AND PUBLIC WATERS".

THE COMMON COUNCIL OF THE CITY OF ONALASKA DOES ORDAIN AS FOLLOWS:

SECTION 1. SECTION 4 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF ONALASKA IS HEREBY CREATED TO BE NUMBERED ENTITLED AND READ AS FOLLOWS:

CHAPTER 9 - TRAFFIC

SECTION 9.4: BOATING AND PUBLIC WATERS

STATE BOATING LAWS ADOPTED. THE STATUTORY PROVISIONS DESCRIBING AND DEFINING REGULATIONS WITH RESPECT TO BOATING IN THE FOLLOWING ENUMERATED SECTIONS OF THE WISCONSIN STATUTES, EXCLUSIVE OF ANY PROVISIONS THEREIN RELATING TO THE PENALTIES TO BE IMPOSED OR THE PUNISHMENT FOR VIOLATION OF SAID STATUTES, ARE HEREBY ADOPTED AND BY REFERENCE MADE A PART OF THIS ORDINANCE AS IF FULLY SET FORTH HEREIN. ANY ACT REQUIRED TO BE PERFORMED OR PROHIBITED BY ANY STATUTE INCORPORATED HEREIN BY REFERENCE IS REQUIRED OR PROHIBITED BY THIS ORDINANCE.

9.4 (A) PENALTIES. ANY PERSON VIOLATING ANY PROVISION OF THIS CHAPTER, INCLUDING THOSE PROVISIONS OF THE WISCONSIN STATUTES WHICH ARE INCORPORATED BY REFERENCE., SHALL UPON CONVICTION THEREOF FORFEIT NOT LESS THAN \$20.00 NOR MORE THAN \$200.00 AND THE COSTS OF PROSECUTION, AND IN DEFAULT OF PAYMENT OF SUCH FORFEITURE AND THE COSTS OF PROSECUTION SHALL BE IMPRISONED IN THE COUNTY JAIL UNTIL PAYMENT OF SUCH FOR FEITURE AND THE COSTS OF PROSECUTION, BUT NOT EXCEEDING 90 DAYS FOR EACH VIOLATION PROVIDED, HOWEVER, THAT IN NO CASE SHALL THE FOREFEITURE IMPOSED FOR A VIOLATION OF ANY PROVISION OF THIS SECTION EXCEED THE MAXIMUM FINE FOR THE SAME OFFENSE UNDER THE LAWS OF THE STATE OF WISCONSIN.

9.4(B) NO PERSON SHALL OPERATE A MOTOR BOAT IN THE CANAL WITHIN THE FIRST ADDITION TO LAUDERDALE ADDITION TO THE CITY OF ONALASKA AT A SPEED GREATER THAN 5 M.P.H. (NO WAKE) AND SHALL NOT CREATE A WASHING SITUATION.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND PUBLICATION.
