

TOWN OF FIFIELD ORDINANCE #
BOATING ORDINANCE

The Town Board of the Town of Fifield do ordain as follows:

Section I. Applicability and Enforcement

- (a) The provisions of this ordinance shall apply to the waters of Round Lake, Pike Lake, and Turner Lake.
- (b) This chapter shall be enforced by the officers of the water safety patrol of the Town of Fifield.

Section II. Intent

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests and the capability of the water resources.

Section III. State boating and Safety Laws Adopted

State boating laws as found in ss. 30.50 to 30.71 are adopted by reference.

Section IV. Slow No Wake Areas

No person shall operate a boat in the following area at a speed faster than "Slow - No Wake", as defined in 30.50(12), Wisconsin Statutes 1988, as -that speed at which a boat moves as slowly as possible while still maintaining steerage control." said "No wake" areas are:

- (1) A narrow channel which exists in the NW 1/4 of SE 1/4, Section 26, T40N, R3E.
- (2) A narrow channel also exists in SW 1/4 of SW 1/4, section 25, T40N, R3E.
- (3) A narrow channel also exists in the N 1/2 of SE 1/4, Section 25, T40N, R3E.

No Entry Areas

No person shall operate a boat in the following "No Entry" areas:

- (1) An area around the osprey nest which is located in the NE 1/4 of the SE 1/4, Section 35, T40N, R3E. These areas will be indicated by buoys placed around each restricted area.

Hazard Areas

No person shall operate a boat in and/or over the following "Hazard" areas:

- (1) A rock which is located in the NE 1/4 of the SE 1/4, Section 35, T40N, R3E.

These areas will be indicated by buoys placed at each hazard area.

Section V. Markers and Navigational Aids Posting ordinance

- (a) Duty, the Town of Fifield shall place and maintain suitable markers and signs in such waters as shall be appropriate to advise the public of the provisions of this chapter and post and maintain a copy of this Section at all public access points within the jurisdiction of the Township.

Section VI. Penalties

Wisconsin state boating penalties as found in ss. 30.80 are adopted by reference.

Section VII. Severability

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

Section VIII. Effective Date

This section will become effective upon passage and the day after publication.
