

ORDINANCE NO. 610

The Common Council of the city of Lake Geneva does hereby ordain as follows:

Section I. Section 20.31 Designated Mooring Areas of Lakes and Beaches of the Municipal Code of the City of Lake Geneva is repealed and recreated to read as follows:

20.31 DESIGNATED MOORING AREAS.

(1) Intent. The intent of this designated mooring section is to provide safe and healthful conditions for the enjoyment of aquatic recreation consisted with public rights and interest and the capability of the Geneva Lake wa ter resource.

(2) State Mooring and Safety Laws Adopted State mooring regulations and regulations applicable to moor-ings as found in the following sections of the Wisconsin Statutes are adopted by reference.

30.15 Penalty of unlawful obstruction of navigable waters

30.16 Removal of obstructions to navigation

30.772 Placement and use of moorings; restrictions; permits

30.773 Designated mooring areas

30.74(2) Uniform Navigation Aids

(3) Establishment.

The City may establish designated mooring areas as provided by Wisconsin Statutes.

(a) Requests for a designated mooring area shall be reviewed by the Piers and Harbors committee of the Common Council.

(b) The description of the proposed designated mooring area shall meet the requirements of S 30.773(2) and S 30.11 Wis. Stats Establishment of Bulkhead Lines.

(c) The proposed designated mooring area shall meet all the standards provided by S 30.773(3) Wis. Stats.

(d) The Piers and Harbors Committee shall cause a Waterway Markers Application Form 8700-58 to be submitted to the Department of Natural Resources. The application shall specify the proposed designated mooring area.

(e) The Common Council may approve or disapprove the establishment of a designated mooring area. A designated mooring area is not established until an approved Waterway Markers Application Form 8790-58 is on file with the Department of Natural Resources marking the mooring area.

(4) Designated mooring areas approved by the City and the Department of Natural Resources shall be open to the public. The regulations of the City may provide for the orderly use of the mooring area by the public.

(5) Placement or removal of moorings in the designated mooring area shall be subject to S 39.33 Mooring Buoys, Lake Geneva Municipal Code.

(6) The City shall establish a system of rules and regulations for use of the mooring area. The rules and regulations may provide for but not be limited to.

(a) Use of moorings, applications, waiting lists, fees.

(b) Placement of moorings, type of moor-ing, weight and size of anchor, attachment of boats.

(7) Designated Mooring Areas are hereby established which are described as:

(a) Designated Mooring Area #1. That area lying northwesterly of the above described launch ramp corridor and northeasterly of the outer mooring line described elsewhere herein and extending to the shore of Geneva Lake, excepting there from that area lying southeasterly of the Riviera docks which is bounded on the southeasterly by a line drawn from a point 210' southeasterly of Dock "B" as measured along the reference line and extending northeasterly through a point which is 70' southeasterly of the southeasterly end of Dock "D" as measured along the center line of the access walk to Dock "D" extended southeasterly.

(b) Designated Mooring Area #3. Embracing the waters of Geneva Lake extending 380' in a southerly direction from the east and west boundaries of Library Park to a line parallel to and 380' distant from the shore of Library Park.

Section II. This Ordinance shall take effect and be in force after its passage and publication.
