## **REVISED ORDINANCE NUMBER 6**

## TOWN OF DAYTON.

## AN ORDINANCE TO REGULATE WATER TRAFFIC, BOATING AND WATER SPORTS UPON THE WATERS OF THE CHAIN 0 LAKES AND PRESCRIBING PENALTIES FOR VIOLATION THERE OF.

The town board of the town of Dayton Waupaca County, Wisconsin do ordain as follows.

Section 1. INTENT: The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of the aquatic recreation consistent with public rights and interest and the capability of the water resource.

Section 2: Applicability and Enforcement. The provisions of this ordinance shall apply to the waters of the Chain 0 Lakes within the jurisdiction

of the town of Dayton. The provisions of this ordinance shall be enforced by officers of the water patrol, officers of the County of Waupaca

Section 3: state boating and safety laws adopted. State boating laws as found in ss.. 30.50 to 30.71 are adopted by reference.

Section 4: Definitions. in this ordinance.

SLOW-NO-WAKE: That speed at which a boat moves as slowly as possible while still maintaining steerage control

WATER CRAFT: A powered boat, vessel, airboat, jet ski, or any contrivance used or designed for navigation on water.

Section 5. Restricted Areas.

The following bodies of water under the jurisdiction of the town of Dayton shall be restricted to Slow-No-Wake.

(a) The channel between Columbia and Long lake in the NW 1/4 NW 1/4 section 4

(b) All of Long Cove located in the NE4 SW 1/4, NW4 SW 1/4, OF SECTION 4.

(c) All of Beasley Lake located in the NW1/4 NW1/4 of section 4.

(d) All of Orland lake located in the NE1/4 SE1/4 of section 5.

(e) All of Knight lake located in the NW1/4 NE1/4 of section 5.

(f) All of Manomin lake located in the NW1/4 NE1/4 of section 5.

(g) All of Pope lake located in the NW1/4 NE1/4, NE1/4 NW1/4, SE1/4 NW1/4, SW 1/4, NE1/4 of section 5.

(h) All of Marl lake located in the NW1/4 SE1/4, SW 1/4, NE1/4, of section 5.

(i) All of Drake lake located in the SE1/4, SW 1/4, NE1/4, SE1/4 NE1/4 of section 4.

(j) All of Miner lake located in the SE1/4 NE 1/4,NE 1/4 NE1/4 of section 4.

(k) The channel in Stratton lake located in the NW1/4 SW 1/4, of section 16.

Section 6:Boating Regulations And Restrictions.

(a) It shall be unlawful, in the town of Dayton to operate any watercraft at any time in any channel at a speed greater than Slow-No-Wake.

(b) It shall be unlawful, in the town of Dayton to operate any water craft during the hours from one half (1/2) hour after sunset to sunrise at a speed greater than Slow-No-Wake.

(c) It shall be unlawful for any person at any time, to water ski, surfboard or participate in a similar activity, or to operate a water craft pulling a water skier, skiers, surf board or similar device upon any of the waters listed in section 5 of this ordinance.

(d) It shall be unlawful for any person to water ski, surf board or participate in a similar activity or to operate a water craft pulling a skier, skiers, surf board or similar device in the town of Dayton Waupaca County WI at any time except in a counter clockwise direction.

(e) It shall be unlawful, for any person to ski, surf board or participate in a similar activity, to operate a water craft, pulling a water skier, skiers, surf board or similar device upon the following waters in the town of Dayton, Waupaca County,Wi.Columbia,Long Spencer and Stratton lakes except between the hours and on the days as follows:

Monday and Friday (except where same falls on a legal holiday) between the hours of 10:00 AM in the morning and 4:00 PM in the afternoon.

Tuesday, Wednesday and Thursday (except where same falls on a legal holiday) between the hours of 10:00 AM in morning and 7:00 PM in the evening. Saturdays, Sundays and legal holidays between the hours of 10:00 AM in the morning and 2:30 PM in the after noon.

The time of day referred to above shall be the official time of the Waupaca County Sheriff department. (f) No person may engage in water skiing, aquaplaning or similar activity at any time from sunset to sunrise.

Section 7. Buoy placement in the town of Dayton.

(a) Slow-No-Wake buoy in Long lake at the entrance to Long Cove on line between SW 1/4 NW 1/4 and NW 1/4 SW 1/4 of section

4 30 feet from west shore line.

(b) Slow-No-Wake buoy at entrance to Beasley lake from Long lake at center of NW 1/4 NW 1/4 of section 4 20 feet off the south west shore line.

(c) Slow-No-Wake buoy west end of channel between Long and Columbia lake 175 feet off the south shore line in the south east corner of NW1/4 NW 1/4 of section 4.

(d) Slow-No-Wake buoy east end of channel between Columbia and Long lake 170 feet off the-south shore line in NE 1/4 NW 1/4 section4.

(e) Slow-No-Wake buoy south end of channel in Stratton lake 90 feet off the west shore line of lot 2 NW1/4 of section 16.

(f) Slow-No-Wake buoy north end of channel in Stratton Lake 25 feet off the west shore line of lot 2 NW4 of section. 16.

Section 8. Permits .

Not withstanding any of the provisions of the preceding sections of this ordinance, the town of Dayton may issue permits for the purpose of conducting water shows, water skiing shows and spectacles by public or private groups or organizations. Said permits shall be obtained from

the Dayton town board. Applications shall be made to the town board at least seven (7) days prior to the event. Proof of insurance must be shown at time of application.

Section 9. penalties.

Wisconsin state boating penalties as found in SS. 30.80 are adopted by reference.

Section 10. Severability.

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Town Board of Dayton would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions or circumstances shall not be affected.

Section 11. EFFECTIVE DATES.

This revised ordinance number 6 shall remain in effect during the entire year.
