A SOLE ORDINANCE TO REGULATE BOATING UPON THE WATERS OF ROUND LAKE AND CHIEF LAKE AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

Adopted on the 13th Day of May, 2014; Amended October 11, 2016; Amended August 14, 2018

The Town of Hayward Board of the County of Sawyer do ordain as follows:

Section I - Applicability and Enforcement

- (a) The provisions of this ordinance shall apply to the waters of Round Lake and Chief Lake.
- (b) This chapter shall be enforced by law enforcement officers of Sawyer County, Town of Hayward, and Wisconsin Department of Natural Resources.

Section II Intent

- (a) The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.

Section III State Boating and Safety Laws Adopted

- (a) State boating laws as found in ss. 30.50 to 30.71, Wisconsin Statutes, are adopted by reference.

Section IV Definitions

- (a) "Slow-No-Wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.

Section V Controlled Areas

- (a) No person shall operate a boat faster than slow-no-wake in the waters of Round Lake or Chief Lake within 100 feet of or between buoys placed by GPS coordinates in the following locations:
 - a. Round Lake: Richardson Bay Point – Bay Side $\text{N}45^{\circ}59.772, \text{W}091^{\circ}19.334$
 - b. Round Lake: Richardson Bay Point – Lake Side $\text{N}45^{\circ}59.793, \text{W}091^{\circ}19.356$
 - c. Round Lake: Leder Bay Island – East buoy $\text{N}46^{\circ}02.276, \text{W}091^{\circ}19.786$
 - d. Round Lake: Leder Bay Island – West buoy $\text{N}46^{\circ}02.248, \text{W}091^{\circ}19.926$
 - e. Round Lake: Hinton Bay Channel – North $\text{N}46^{\circ}01.289, \text{W}091^{\circ}19.738$
 - f. Round Lake: Hinton Bay Channel – South $\text{N}46^{\circ}01.428, \text{W}091^{\circ}19.742$

- g. Chief Lake: Daggets Resort – Buoy 1 N45°53'49.07", W91°18'04.95"
- h. Chief Lake: Daggets Resort – Buoy 2 N45°53'41.06", W91°18'04.95"
- i. Chief Lake: Daggets Resort – Buoy 3 N45°53'43.27", W91°18'05.31"
- j. Chief Lake: Daggets Resort – Buoy 4 N45°53'36.87", W91°18'02.34"
- k. Chief Lake: Daggets Resort – Buoy 5 N45°53'31.57", W91°18'02.65"

Section VI Posting Requirements

- (a) The Town of Hayward shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town of Hayward pursuant to the requirements of NR 5.15 Wisconsin Administrative Code.

Section VII Penalties

- (a) Wisconsin state boating penalties as found in Wisconsin Statute 30.80 and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.


Section VIII Severability


Section IX Effective Date

The Town of Hayward Board of the County of Sawyer do ordain as follows:

Section I - Applicability and Enforcement

- (a) The provisions of this ordinance shall apply to any navigable waterway within the Town of Hayward.
- (b) This chapter shall be enforced by law enforcement officers of Sawyer County, Town of Hayward, and Wisconsin Department of Natural Resources.

- (a) The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.
