Council Activities:

- Council Meetings

 - Trying to increase local engagement by holding incentive updates earlier and having a sign-up meeting 3/27/23
 - New county staff partnership with Tina Barone of Dunn county instead of Amanda Hanson.
 - O Dry Run: Held a council meeting in January
 - Directed incentive program to be finalized and mailed out in February.
 - Considering a buffer event for summer to help people see them more.
 - Have a new farmer (organic) who is getting active at meetings.
 - Participating in NOPP (nitrogen optimization pilot program).
 - Horse Creek: Held a council meeting in January
 - Planning an event for 3/23/23 focused on nitrogen management.
 - They are looking at doing more with streambank stabilization and engineering practices for incentives and projects.

 - They are working more with local groups GROWW for pollinator projects,

 - Presented to roughly 50 people at the Northwest Beef Producers Association on soil health and FLWCs – got great feedback.

- Partnership building
 - Met with GROWW (Grassroots Organizers of Western Wisconsin) about pollinator awareness campaign.
 - Attendance at WWCC (Western Wisconsin Conservation Council) annual meeting where one of my Horse Creek farmers spoke and Horse Creek demo site research was highlighted.
 - Working with IWI (international Water Institute) to find farmers to try their Field
 Stewardship Rating no farmers signed up so far
 - Worked with Extension on support for autonomous cover crop vehicles.
 - Worked with UWRF staff to support pollinator research strips, NOPP grant, and drone research.
 - Attended Producer-Led and Cover Crop Conference & Discovery Farms Conference in Wisconsin Dells.
 - Attended Red Cedar Conservation Farmers education day on biologicals in Colfax –
 working more closely with this council to connect them with Hay River farmers more.
 - Met with Chase Cummings and Tina Barone to shore up some partnership gaps with Dunn county.
 - Met with St. Croix county to get a better picture of their nitrogen research and consider how we could package the messaging for public consumption.
 - Attended the Wisconsin Corn & Soybean Expo this was a very interesting event and a
 great opportunity to network with conventional farmers with very limited interest in
 (and some antipathy towards) conservation.
 - Connected to new LSP livestock specialist, Caleb Langworthy, and new RC&D grazing specialist, Chris Johnson. We are working on getting a better picture of all of the people working on grazing in the area, trying to consolidate efforts.
- Virtual outreach has continued with continued updates to the website, quarterly e-newsletter and facebook.
 - Newsletter has 336 subscribers.
 - Winter newsletter went out in December with a 52% open rate
 - Another newsletter will be going out in March
 - Website had 655 views in the last 90 days
 - Facebook presence is maintained, followers up to 408
 - We continue to get good feedback from the farmers on our Facebook page
 - 2900 impressions in the last 90 days (up 29% from previous 90 days according to Facebook).
