# AN ORDINANCE TO MODIFY SECTION 42.02(F)(2) OF THE VILLAGE OF **RICHFIELD CODE OF ORDINANCES**

Section 1: Section 42.02(F)(2) is amended as follows:

2. No person shall operate a boat at a speed greater than 35 miles per hours from 10 a.m. to 7 p.m. on Friess Lake. At all other times, the maximum speed shall be slow-no-wake.

Section 2: This ordinance shall become effective upon passage and posting.

Section 3: Several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific Section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions. Sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

# AN ORDINANCE TO MODIFY SECTION 42.02(I)(2) OF THE VILLAGE OF RICHFIELD CODE OF ORDINANCES

2. No person shall operate nor shall any boat owner allow a boat to be operated to tow more than two persons on water skis, aquaplanes or other similar devices at any one time.

Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.
