

ORDINANCE NO 2011-004

AN ORDINANCE TO AMEND SECTIONS 8.04(1)B and 8.04(1)C OF THE CODE OF ORDINANCES FOR THE TOWN OF NORWAY, RACINE COUNTY, WISCONSIN, RELATING TO SLOW-NO-WAKE LIMITS ON LONG LAKE

The Town Board of the Town of Norway, Racine County, Wisconsin, do ordain as follows:

1. That Subsections 8.04(1)B and 8.04(1)C of the Municipal Code of the Town of Norway, relating to slow-no-wake limits on Long Lake, be, and hereby are, amended to read as follows:

8.04 BOATING REGULATIONS

1. Speed

(B) Except as set forth under Section 8.07(3) and unless an area is otherwise marked, no person may operate a personal watercraft, a motorboat, or any watercraft within 300 feet of any main shoreline on any lake, other than Long Lake, at a speed in excess of slow-no-wake speed, or as otherwise established by regulatory markers.

(C) Except as set forth under Section 8.07(3) and unless an area is otherwise marked, no person may operate a personal watercraft, a motorboat, or any other watercraft within 200 feet of any main shoreline on Long Lake at a speed in excess of slow-no-wake speed, or as otherwise established by regulatory markers."

2. That this ordinance was reviewed and approved by the Wisconsin Department of Natural Resources on June 1, 2011 as DNR ID #944.

3. That this ordinance shall take effect upon adoption, publication and posting as required by law.

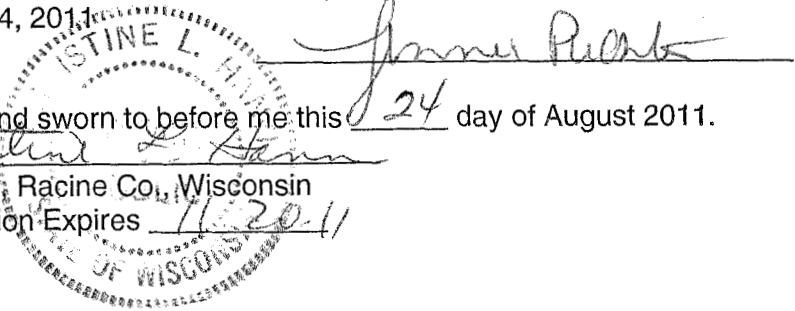
