The field work will be conducted during the summer months of 2004, with the aquatic plant management plan developed by December 31, 2004. The plan will be used to direct aquatic plant management activities on the Waupaca Chain O'Lakes. The plan must be approved Department of Natural Resources Aquatic Plant Manager. The plan will be provided to lake residents, Waupaca Chain O'Lakes District, Waupaca Chain O'Lakes Association, Waupaca County Land and Water Conservation Department and Wisconsin DNR.
