Purpose: FDL Long Lake Association proposes to continue to monitor and control aquatic invasive species (AIS) on a lake-wide basis in Long Lake through 2018. The project will include: qualitative evaluations where the entire littoral zone of Long Lake would be searched for AIS, quantitative evaluations before and after treatments, chemical treatment of AIS, two years of volunteer-based herbicide concentration monitoring, professional hand-harvesting of AIS, assessment of mechanical harvesting operation, acoustic survey, whole-lake point-intercept survey, stakeholders survey, 200 hours per year of Clean Boats/Clean Waters monitoring, public and committee meetings, annual AIS monitoring and control strategy assessment reports, and development of an updated aquatic plant management plan which will include a harvesting plan. Long Lake will submit a final report summarizing the project to the Department. The project elements and deliverables will be completed as described in the project proposal submitted to the Department and dated January 28, 2015.
