**Purpose:** The Waunakee Urban Service Area was established in 1971 with the adoption of the first sewer service plan. The boundaries of the Waunakee Urban Service Area were cleaned up in 1977 and Environmental Corridors delineated in 1984/1985. The first amendment occurred in 1988. There have been 15 amendments to this service area since its creation totaling 1,489 acres of developable land and 662 acres of Environmental Corridor. The most recent amendment of the service area by the Village was recommended by the Commission and approved by the WDNR in 2021, adding roughly 20 acres adjacent the Waunakee Business Park (DNR Project Number DC-0211).

**Objective:** Cost-effective, environmentally sound development within the defined urban service area and adjacent lands through detailed planning and SSA Plan amendment processes via the Dane County Water Quality Management Plan. This planning process is administered by the Capitol Area Regional Planning Agency.
