 \2022 Integrate individual plans into one beach club plan and present for review and possible approval to Tri-Lakes Management District and watershed 9 Key Element planners for incorporation into their plans--also present beach club plan to WDNR for approval
 Deliverables: All data collected, all outreach and event materials, agendas and minutes from meetings.
 \2022 List of all owners to be contacted for each club
 \2022 Identification of problem issues for each project parcel
 \2022 Parcel-specific designs for each project parcel with alternatives for each problem issue identified
 \2022 Formation of advisory groups for each parcel and determination of priorities for each
 \2022 Draft plan to present to the multiple owners of each project property
 \2022 Incorporation of chosen plans into larger plans
