Purpose: To cost-share landowner installation of best management practices designed to enable the farm operations to remedy the Notice of Intent to Issue a Notice of Discharge issued by Marathon County on February 12, 2007, and to comply with the agricultural performance standards and prohibitions established by the County's Animal Waste and Manure Management Code and Subchapter II of NR 151 by establishing manure management systems which will enable the Clarence Tryba Farm to close failing/leaking manure storage systems, meet nutrient application restrictions, prevent overflow from manure storage facilities, remove the threat to public health, eliminate unconfined manure piles in water quality management areas, prevent direct runoff from a feedlot or stored manure into waters of the state, and prevent unlimited livestock access to waters of the state.
