Selective, manual eradication efforts by divers will severely suppress the population, if not completely eliminate EWM from the lake if possible. A secondary goal will be the preparation of an aquatic plant management (APM) plan designed to protect the native plant community and develop a long-term strategy for preventing re-expansion of EWM in the lake. The following project deliverables are expected: 1) a completed APM plan; 2) documentation of existing EWM colonies based on GPS locations, colony counts and biomass measurements collected immediately before the manual pulling of all plants found; 3) data sharing which will involve public presentations, facts sheets, and press release to increase public awareness for the need to prevent the spread of exotic species.
