Project activities include: 1) Recruit volunteers and implement a CB/CW program at Lincoln County landings; 2) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines; 3) Host CB/CW and AIS monitoring workshops; 4) Entry of inspection Forms 3200-120 and monitoring Forms 3200-124 and/or 3200-130 onto Dept website; 5) Create a CB/CW shelter with supplies for county use; 6) Disseminate AIS information at Tomahawk Sport Show booth, Annual Meeting, and riparian owner letter.

Project deliverables include: 1) Completed entry of inspection Forms 3200-120 and monitoring Forms 3200-124 onto Dept website; 2) Picture of CB/CW shelter and supplies; 3) Assembled AIS information (booth, educational materials, riparian owner letter); 4) Final report summarizing CB/CW activities, AIS monitoring, and AIS educational activities.
