Purpose: The Town of Three Lakes is sponsoring an AIRR grant to be completed by June30, 2010. The project will focus on surveying, mapping and managing (chemical treatments and hand-pulling) all of the Eurasian Watermilfoil located in the Eagle River between Long Lake (Three Lakes Chain) and Cranberry Lake (Eagle River Chain).

Project activities include: 1) Pre-treatment survey and mapping conducted a week or less prior to management; 2) manage EWM; 3) Post-treatment survey between mid-July and mid-August.

Project deliverables include: 1) Final report describing the findings of the pre and post treatment surveys, GPS locations, and guidance for continued control actions.

Specific conditions: Final report needs Dept. review and approval.
