Purpose: The Eagle Creek River Management Organization (ECRMO) proposes to control Eurasian Water-milfoil (EWM) in Eagle Creek by implementing control measures during the period 2010-2012. The project elements and deliverables are specified in the Eagle Creek River Management Organization Aquatic Invasive Species Control Grant application, dated January 28, 2010. The project includes conducting pre- and post-treatment surveys and mapping the extent of EWM;; controlling EWM with aquatic herbicide treatments; and implementing an aquatic invasive species prevention strategy that includes developing an awareness & education program. Annual progress reports and a final report summarizing the three-year project will be provided to DNR.
