Completion of a LMP will allow for potential Aquatic Invasive Species (AIS) cost sharing grants and permits for Eurasian water-milfoil (EWM) control. Phases 1 and 2 were funded in this grant cycle (Feb 2010) and Phase 3 will be submitted for funding in August 2010.

Phase 2 project activities include: 1) Point-intercept (PI) aquatic plant survey, community mapping and analysis; 2) Curly-leaf pondweed survey.

Project deliverables include: 1) PI data; 2) Aquatic plant community maps; 3) Two sets of aquatic plant vouchers.
