5) Point intercept surveys shall follow Recommended Baseline Monitoring of Aquatic Plants in Wisconsin: Sampling Design, Field and Laboratory Procedures, Data Entry and Analysis, and Applications, publication number PUB-SS-1068. Submit electronic point intercept data to this email address: DNRBaselineAquaticPlants@wisconsin.gov

6) All monitoring shall follow DNR protocols.

7) Draft user survey questions to be reviewed and approved by DNR Social Scientist before distribution or use.
