Green Bay Metropolitan Sewerage District's (GBMSD) ambient monitoring program collects water quality data at several Purpose:

stations in the AOC. However, no information is collected on aesthetic parameters including "floating or submerged debris, oil, scum" or "materials producing color, odor, taste, or unsightliness" detailed in the delisting target. Decisions about the aesthetic quality of water are also subjective in nature and involve personal interpretation of what is an "unacceptable level" or

an "objectionable" amount that would interfere with public rights or impair use.

Objective: This project will develop a monitoring program that will use local residents to monitor aesthetics in the Lower Green Bay and

Fox River Area of Concern (AOC). The primary goal of the project is to gain input for evaluation of the Degraded Aesthetics beneficial use impairment (BUI) in this AOC. Benefits of this approach include expanding public participation in AOC activities, generating needed data at minimal cost, and incorporating public perceptions in evaluation of this BUI.

Comments: Original grant was awarded in 2011, but this project is ongoing. We intend to apply for AOC capacity grant funding each year

to continue the monitoring project as long as it is needed. The delisting target is 5 years of acceptable aesthetics results. -

LTE reporting done under this project - funded through 2014

Outcome: Results will be used to evaluate the status of the impairment and to identify improvement opportunities. Quarterly and final

reports will be completed as required, and results will be incorporated in annual Remedial Action Plan Updates for this AOC.

Study Design: Dedicated citizen volunteers conduct detailed aesthetics surveys at specific monitoring sites (public access points) within the AOC. Surveys are conducted from April through October, at least twice a year (during 2 seasons). There are also plans to

hire a student to go to monitoring sites and use a shortened survey to gain opinions from a wider public.

Activities planned for next quarter include providing ongoing support to dedicated volunteers, collecting and reviewing their completed surveys, providing support for student surveyor, and working with new data support LTE (when hired) to begin to enter 2013 survey data in SWIMS, upload 2011-2013 photos to SWIMS, update project QAPP, and analyze and interpret 2012 data to develop a final 2012 report.

Final project expenses for the UWEX portion of the grant totaled \$1,245.96, including \$1,005.90 for the student surveyor's salary (plus indirect costs) and \$240.06 for mobile hotspot rental (so student could enter survey responses directly into SWIMS). (Obviously, the \$2,000 estimate for student salary in the last report was off by quite a bit.) The expenses and activities for the data support LTE are approved under a different grant and will be submitted in a separate quarterly report. Activities Completed This Quarter: Activities this quarter for the AOC Coordinator included providing ongoing support to 16 dedicated volunteers, collecting and reviewing their completed surveys, holding an end-of-season meeting with the volunteers to get their feedback on the program, collecting volunteers' monitoring equipment, assisting the UWGB student conducting citizen surveys, and working with the data support LTE to begin analysis of the 2011-2013 survey data. During this quarter, 18 aesthetics surveys were received from dedicated volunteers and reviewed, for a total of 72. The student surveyor visited the same 11 monitoring sites (parks and boat launches) that the dedicated volunteers are monitoring and intercepted park/launch visitors to administer a short citizen survey. He completed the citizen surveys in early October, and collected and entered a total of 118 of these short surveys into the SWIMS database. More details can be found in the UWEX final report which has been uploaded to SWIMS. Problems/Issues: As reported earlier, one problem encountered this year is that some of the dedicated volunteers have been too busy to monitor, and fewer surveys were completed than were originally planned. Thus, we have fewer surveys to include in
