Project activities include: 1) Hire an AIS coordinator; 2) Recruit volunteers and implement a CB/CW program; 3) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines; 4) Entry of inspection and monitoring forms into SWIMS; 5) AIS education- disperse information in local community, share results of project in newsletter and local media, and host a volunteer recognition dinner; 6) Purple loosestrife and yellow iris hand removal; 7) Develop final report.

Project deliverables include: 1) Entered inspection and monitoring data into SWIMS; 2) AIS coordinator; 3) AIS educational and outreach activities; 4) Controlled purple loosestrife and yellow iris; 5) Final report summarizing CB/CW activities, AIS monitoring, AIS educational activities and AIS hand removal efforts.
