1. Pre and two post plant point intercept surveys 2. Whole-lake fluridone slow release pellet treatment at 16PPB. 3.Maintain 2-4 PPB within the treatment areas for 120 days with a potential bump application if levels drop below 3 P 4.Residual herbicide monitoring 5.Full point-intercept plant surveys pre and post-treatment 6.Assist Golden Sands Clean Boats / Clean Waters program 7.Scuba diver assisted harvesting of EWM 8.Management report to quantify results, make future recommendations.
