- 3) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines
- 4) Conduct 2 shoreline sweeps
- 5) Conduct "Guided AIS Monitoring"
- 6) Entry of inspection forms 3200-120 and monitoring forms onto Dept website
- 7) Develop a local "Plan of Action" for AIS containment and management
- 8) Build portable CB/CW kiosks
- 9) Assemble 10 AIS monitoring equipment packages

- 1) Completed entry of inspection 3200-120 and monitoring forms onto Dept website
- 2) An AIS containment and management plan
- 3) Portable CB/CW kiosks
- 4) AIS monitoring equipment packages
- 5) Final report summarizing CB/CW activities, AIS monitoring, and the AIS plan of action
