Project activities include: 1. Complete an EWM proposed treatment survey; 2. Complete Pre/Post treatment survey; 3. Chemically treat approximately 30 acres of EWM; 4. Prepare Aquatic Plant Management Report.

Project deliverables include: Final report describing the findings of the pre and post treatment surveys, GPS locations, updated EWM maps, and guidance for continued control actions.

Specific conditions for this project: Final report needs Dept review and approval; all EWM surveys must follow WDNR Pre and Post treatment monitoring protocols (April 2008)
