Project activities include: 1) Recruit volunteers and implement a CB/CW program at Pelican Lake landings; 2) Hire 2 AIS coordinators; 3) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines; 4) Entry of inspection Forms 3200-120 and monitoring Forms 3200-124 onto Dept website; 5) Disseminate AIS information at boat landings, public areas, resorts, campgrounds, businesses, tournaments, in newsletter article(s) and in news releases.

Project deliverables include: 1) Minimum of 400 watercraft inspection hours; 2) Completed entry of inspection Forms 3200-120 and monitoring Forms 3200-124 onto Dept website; 3) Assembled AIS information and newsletter article(s); 4) Hired coordinators; 5) Final report summarizing CB/CW activities, AIS monitoring, and AIS educational activities.
