Our costs were up significantly due to three new kids working with someone early in the summer and more administrative work being assigned to Gina from the start of the year.

Although we had a cool summer, the number of boats inspected was more than in 2013. People contacts were down based on a procedure change, i.e., only those that are involved in answering the questions being counted as opposed to the total number that may be a part of the group in the boat.

As in previous years, we found boaters very knowledgeable about the aquatic invasive species laws, including removing any plants from the boat/trailer before leaving the launch.

I am recommending this program continue in 2015, however, as I have discussed with you, our kids do not meet my expectations (while may be too high for the age group we employ). Deputy Warden Water Guard Marcus Medina characterized his experience with one of our employees as "passive". They need to be more assertive and engaging, but that is asking a lot based on their personalities/ages. I found myself as less assertive, i.e., more accepting of the circumstances, when leading by example did not improve their performance.

We need to explore other options in the leadership role.
