

## **WDNR WATER QUALITY PLANNING PROGRAM PROGRESS REPORT – OCTOBER, 2014 EAST CENTRAL WISCONSIN REGIONAL PLANNING COMMISSION**

### SSA Plan Updates & Mapping

East Central staff continued to work on the Fond du Lac, Eden and Oakfield SSA Plan Updates as follows:

- Staff met with the Village of Eden to discuss priority development areas and allocation projections based on the existing and future land use summaries. The result of this meeting was mapped and acreage areas quantified for comparison to residential and industrial acreage needs/projections. Based on this information additional support tables were developed for inclusion in the final plan document. The draft allocation scenario mapping was finalized and submitted to the respective service areas for comments and additional input. Draft map exhibits were being developed for the Oakfield and Eden SSA draft plan documents.
- Staff began developing the text for the Oakfield and Eden Sewer Service Area based on the data collected and created during the update process.

East Central staff continued to work on other SSA issues as follows:

- Staff filled a data request, (sanitary district boundaries), for the Calumet County Resource Management Department to help them create a utility assessment report for the county.
- Staff provided the Town of Buchanan with a clarification of the Darboy Sanitary District boundary and mapping assistance.
- Staff reviewed and commented on a sewer feasibility study submitted by the Town of Winneconne. This study directly involves the Butte des Morts Consolidated Sanitary District and the wastewater treatment facility. This is an on-going technical assistance project provided by East Central.
- Staff completed the summary of proceedings from the September 17, 2014 Community Facilities Committee.
- Staff prepared and held a Community Facilities Committee meeting whereby the committee approved lifting a sewer extension hold area within the 2030 Heart of the Valley SSA, (V. Harrison). This approval is contingent upon the Village and Town of Harrison amending their comprehensive land use plan to reflect the land use and zoning changes associated with this amendment.

SSA Plan Updates & Mapping

East Central staff continued to work on the Fond du Lac, Oakfield and Eden SSA Plan Updates as follows:

- o Staff continues to format and edit the draft plan documents for the Eden and Oakfield 2035 Sewer Service Area Plan updates. Follow up phone conversations with the Village of Oakfield were held to clarify the proposed allocations and minor changes were made.
- o The Fond du Lac SSA plan continues on standby until the Outlying Sewer Group Agreement is finalized. The technical and executive committees continue to address outstanding issues.

East Central staff continued to work on other SSA issues as follows:

- o Staff continued to develop the mapping exhibits, (16), for the 2035 Oakfield and Eden Sewer Service Area Plan updates..
- o Staff assisted the Public Service Commission and its intern in acquiring updated corporate limit data within the Heart of the Valley SSA. This being part of a PSC municipal drinking water study.
- o Staff reviewed a proposed resolution by the City of Omro regarding the sewer user fee structure involving the Omro Sewer Service Area and the Algoma Sanitary District. This action stems from recent actions by the Algoma Sanitary District in its annexation effort with the Town of Omro Sanitary District. East Central continues to monitor this situation.

- Staff continued to write, edit and format the plan documents for the 2035 Eden and Oakfield Sewer Service Area plan updates. In addition, mapping exhibits were finalized and inserted into the document.
- The Fond du Lac Outlying Sewer Group and their Executive and Technical Committees did not meet in December, 2014. Inquiries to the committee chairman were made as to the status of the OSG agreement.

Other

- Staff assisted the Village of Harrison with 2030 Heart of the Valley and 2030 Neenah-Menasha SSA data for use in their analysis for lifting a sewer extension hold area within the Village.
- Staff fielded inquiries regarding a proposed development in near proximity to the Greenville Sanitary District and the 2030 Grand Chute-Menasha West SSA. This issue may be problematic as an amendment to the service area seems unlikely. East Central currently opposes any private on-site sewage systems within the 2030 GCMW SSA.
